Partial Suspension of Minimum Biodiesel Requirement

Explanatory note

The object of this Order is to amend the *Threatened Species Conservation Act 1995* (**the Act**):

- (a) to insert an asterisk before the names of certain threatened species in Schedules 1, 1A and 2 to the Act to indicate their national status for species that are listed as threatened species under the *Environment Protection and Biodiversity Conservation Act 1999* of the Commonwealth (**the Commonwealth Act**), and
- (b) to omit the asterisk before the names of certain other threatened species in Schedules 1, 1A and 2 to the Act to indicate that they are not listed as threatened species under the Commonwealth Act.

This Order is made under section 9 of the *Threatened Species Conservation Act 1995*.
