### SPECIAL SUPPLEMENT

#### FISHERIES MANAGEMENT ACT 1994

Section 183 – Quarantine Order

**OX** Disease

I, BRUCE CHRISTIE, Principal Director, Biosecurity, with the delegated authority of the Minister for Primary Industries and the Director General of the Department of Trade and Investment, Regional Infrastructure and Services pursuant to sections 227 and 228 of the Fisheries Management Act 1994 ("the Act"), do by this order:

- pursuant to section 183 of the Act and section 43 (2) of the Interpretation Act 1987, repeal the Quarantine Order titled "Section 183 Quarantine Order QX Disease" published in *New South Wales Government Gazette* No. 75 of 22 May 2009, at pages 2307-2308;
- 2 pursuant to section 183 of the Act:
  - (i) declare each the following estuaries to be a quarantine area ("the Quarantine Areas") because of the presence or suspected presence of the declared disease marteiliosis (QX disease):
    - (a) Richmond River
    - (b) Clarence River
    - (c) Macleay River
    - (d) Hawkesbury River
    - (e) Georges River
    - (f) Tweed River
    - (g) Brunswick River
    - (h) Bellingen-Kalang River
  - (ii) prohibit the taking of oysters or the movement of cultivation equipment and/or infrastructure from the Quarantine Areas except under the following conditions:
    - (a) oyster cultivation equipment and infrastructure (eg. oyster sticks, trays, baskets) used in any of the Quarantine Areas must be dried for 30 days before use in any other NSW estuary.
    - (b) oysters, oyster cultivation equipment and infrastructure may be relocated between the Quarantine Areas but only in accordance with the Oyster Shipment Log Book System for the Movement of Oysters, Oyster Cultivation Equipment and Infrastructure which is detailed below in Schedule 1.
    - (c) oysters may be taken and culled in or adjacent to the Quarantine Areas or in accordance with a protocol approved by the Principal Director, Biosecurity.
  - (iii) exclude sections 185 and 186 of the Fisheries Management Act 1994 with respect to oysters taken from the Quarantine Areas or any part of the Quarantine Areas in accordance with this order (but only in relation to the declared disease marteiliosis (QX disease).
  - (iv) require all holders of aquaculture permits within the Quarantine Areas to follow all directions of a fisheries officer made under section 183 (4) of the Act.

#### SCHEDULE 1

Oyster Shipment Logbook System for the Movement of Oysters, Oyster Cultivation Equipment and Infrastructure

- (1) All shipment of oysters, oyster cultivation equipment and infrastructure other than those within an estuary or those destined for direct sale for human consumption must be recorded in an Oyster Shipment Log Book prior to shipment.
- (2) Not less than 2 days prior to the shipment of a consignment of oysters, oyster cultivation equipment and infrastructure between estuaries, the shipping permit holder must contact the local District Fisheries Office and identify the shipper, the nature of the shipment and its destination and the Oyster Shipment Log Book shipment permit number (top right hand corner of the shipment sheet).
- (3) Prior to the shipment of oysters, oyster cultivation equipment and infrastructure, the shipping permit holder must record on all four (4) quadruplicate copies of the Oyster Shipment Log Book sheets, details of the destination (including interstate), quantity (bag equivalents) and form (trays, sticks, etc) of oysters to be shipped.
- (4) For each shipment of oysters, oyster cultivation equipment and infrastructure, the completed original white copy (copy 1) of the Oyster Shipment Log Book sheets must accompany the shipment and be retained by the receiving permit holder.
- (5) The Oyster Shipment Log Book or the original white copy (copy 1) of the Oyster Shipment Log Book that has accompanied a shipment, must be made available to a Fisheries Officer for inspection on demand.
- (6) The holder of an Oyster Shipment Log Book must at the end of each month in which a shipment has occurred, forward all blue copies (copy 3) for those shipments to NSW Department of Primary Industries Aquaculture Management at the address specified below.

Note: Oyster Shipment Log Books are available on application from NSW Department of Primary Industries Aquaculture Administration, Locked Bag 1, Nelson Bay NSW 2315 or by phoning (02) 4982 1232.

In this Schedule, a reference to an estuary in paragraph 2 (i) includes a reference to all creeks, rivers, lakes, lagoons and tributaries flowing into or from that estuary and any jetty, wharf, boat ramp or land used for aquaculture purposes in the immediate vicinity of the water.

This order is in force for a term of four years commencing on the date of publication of this order unless sooner amended or revoked.

Note: In addition to complying with the terms of this order, the taking of oysters or the movement of oyster cultivation equipment and/or infrastructure must comply with the terms of any fishing closure made under section 8 and section 11 of the Fisheries Management Act 1994 including the fishing closure titled "QX Disease" of 11 July 2008 published in the *New South Wales Government Gazette* No. 87 of 11 July 2008, at page 6994-6996 as amended by the fishing closure titled "QX Disease" of 18 May 2009 published in the *New South Wales Government Gazette* No. 75 of 22 May 2009, at page 2307.

### PLANT DISEASES (FRUIT FLY OUTBREAK, MURRAY VALLEY HWY, STRATHMERTON) ORDER 2011

under the Plant Diseases Act 1924

I, SATENDRA KUMAR, Director Plant Biosecurity of the Department of Trade and Investment, Regional Infrastructure and Services, with the delegated authority of the Minister for Primary Industries in pursuance of section 3A of the Plant Diseases Act 1924 ("the Act"), and in pursuance of section 4 of the Act being of the opinion that the importation, introduction or bringing of host fruit into specified portions of New South Wales is likely to introduce the pest Queensland fruit fly (Bactrocera tryoni) into specified portions of New South Wales, make the following Order regulating the importation, introduction or bringing of host fruit into specified portions of New South Wales.

#### 1 Name of Order

This Order is the Plant Diseases (Fruit Fly Outbreak, Murray Valley Hwy, Strathmerton) Order 2011.

#### 2 Commencement

This Order commences on the date it is published in the NSW Government Gazette.

#### 3 Interpretation

(a) In this Order:

approved treatment means a treatment or schedule of treatments relevant to the type of host fruit or manner of harvest as specified in Schedule 6.

APVMA means the Australian Pesticides and Veterinary Medicines Authority.

authorised person means an inspector or a person authorised pursuant to section 11 (3) of the Act.

certificate means a Plant Health Certificate or a Plant Health Assurance Certificate.

**Certification Assurance Arrangement** means an arrangement approved by the Department which enables a business accredited under the arrangement to certify that certain quarantine requirements have been satisfied for the movement of host fruit to interstate and/or intrastate markets.

Note: An example of an approved Certification Assurance Arrangement is the Interstate Certification Assurance (ICA) Scheme.

**Department** means Industry and Investment, NSW – Primary Industries.

*free of broken skin* means the skin has no preharvest cracks, punctures, pulled stems or other breaks which penetrate through the skin and that have not healed with callus tissue.

host fruit means the fruit specified in Schedule 1, being fruit which is susceptible to infestation by Queensland fruit fly.

lot means a discrete quantity of fruit received from one grower at one time.

Outbreak Area means the portion of New South Wales described in Schedule 2.

*Outer Area* means the portion of New South Wales known as the NSW Fruit Fly Exclusion Zone, as specified in Proclamation P184 published in *NSW Government Gazette* No. 152 of 28 November 2008 at pages 11434 to 11435, excluding the Outbreak Area and the Suspension Area.

**Plant Health Assurance Certificate** means a certificate issued by a business accredited under a Certification Assurance Arrangement.

Plant Health Certificate means a certificate issued by an authorised person.

Queensland fruit fly means the pest Bactrocera tryoni (Froggatt).

Suspension Area means the portion of New South Wales described in Schedule 3.

the Act means the Plant Diseases Act 1924.

Note: covering or package, inspector, occupier and owner all have the same meaning as in the Act.

(b) In this Order, longitude and latitude coordinates are decimal degrees based upon the GDA 94 datum.

#### 4 Regulation of the movement of host fruit

Pursuant to section 4 (1) of the Act the importation, introduction or bringing of host fruit into specified portions of New South Wales is regulated as follows:

- (a) Host fruit that originates from or has moved through:
  - (i) the Outbreak Area must not be moved into the Suspension Area or the Outer Area;
  - (ii) the Suspension Area must not be moved into the Outer Area,

except for such movements as are specified in Schedule 5 and which comply with the relevant conditions of exception set out in Schedule 5; and

- (b) The movement of any host fruit in accordance with Schedule 5 must be accompanied by a certificate:
  - (i) specifying the origin of the host fruit; and
  - (ii) in the case of a Plant Health Certificate, certifying that the host fruit has been treated in the manner specified in Schedule 6; and
  - (iii) in the case of a Plant Health Assurance Certificate, certifying that the host fruit originates from a property or facility which is owned or occupied by a business accredited under a Certification Assurance Arrangement.


#### SCHEDULE 2 - Outbreak Area

The area within a 1.5 kilometre radius of the coordinates decimal degrees -35.92475 South and 145.47952 East, being the area within the 1.5 kilometre radius circle (broken line) in the map in Schedule 4.

#### **SCHEDULE 3 – Suspension Area**

The area within a 15 kilometre radius of coordinates decimal degrees -35.92475 South and 145.47952 East (excluding the Outbreak Area), being the area between the 1.5 kilometre radius circle (broken line) and the 15 kilometre radius circle (unbroken line) in the map in Schedule 4.

#### SCHEDULE 5 - Exceptions for movement of host fruit

#### Host fruit that has received an approved treatment

- 1. Movement of host fruit that has received an approved treatment prior to movement, subject to the following conditions:
  - (a) The owner or occupier of the property or facility from which the host fruit originates must ensure that the host fruit remains under secure conditions from post harvest to the time of dispatch and transport, except when impractical during packing and grading activities; and
  - (b) Prior to movement, the owner or occupier of the property or facility from which the host fruit originates must ensure that:
    - any used packaging or coverings containing host fruit are free of soil, plant residues and other organic matter;
       and
    - (ii) in the case of host fruit that has been consigned as a lot for the purpose of producing smaller packs of host fruit and has been repacked in smaller packs, the host fruit has been received, handled, stored and repacked under secure conditions which prevent infestation by Queensland fruit fly; and
    - (iii) any individual package contains only one kind of host fruit; and
    - (iv) all previous incorrect information displayed on the outer covering of the package is removed and the outer covering is legibly marked with the following information:
      - (A) the district of production; and
      - (B) the name, address, postcode and the State or Territory of both the grower and the packer; or where the business is sourcing from multiple growers, the name, address, postcode and the State or Territory of the packer; and
      - (C) a brief description of the contents of the package;

or

(v) where the host fruit originates from a property or facility which is owned or occupied by a business accredited under a Certification Assurance Arrangement, the host fruit is packed, labelled and certified in accordance with any conditions prescribed in the Certification Assurance Arrangement.

#### Untreated host fruit for processing

- 2. Movement of untreated host fruit for processing, subject to the following conditions:
  - (a) The owner or occupier of the property or facility from which the host fruit originates must ensure that the host fruit remains under secure conditions from post harvest to the time of dispatch and transport, except when impractical during packing and grading activities; and
  - (b) Prior to movement, the owner or occupier of the property or facility from which the host fruit originates must
    - (i) all bins or containers and any vehicles to be used for the transportation of host fruit ("transport vehicle") are free from all plant debris and soil prior to packing and loading; and
    - (ii) the host fruit is securely covered by a tarpaulin, shade cloth, bin cover or other covering or contained within the covered transport vehicle so as to prevent infestation by Queensland fruit fly and spillage during transportation; and
    - (iii) the host fruit must be loaded onto or into a transport vehicle on a hard surface and not within the orchard from which the host fruit was sourced; and
    - (iv) the transport vehicle is free of all soil and plant debris after loading; and
    - (v) the transport vehicle travels by the most direct route to the receiving processor; and
  - (c) The owner or occupier of the property or facility at which the host fruit is to be processed must ensure:
    - (i) the host fruit is processed within 24 hours of receipt; and
    - (ii) all measures to avoid spillage of host fruit are taken and where spillages occur, must be disposed of in a manner generally accepted as likely to prevent the spread of Queensland fruit fly; and
    - (iii) all processing wastes must be disinfested by heat or freezing or be buried.

#### Outer Area host fruit on a direct journey through the Outbreak Area or Suspension Area into the Outer Area

- 3. Movement of host fruit originating within the Outer Area and moving on a direct journey through the Outbreak Area or the Suspension Area into the Outer Area, subject to the following conditions:
  - (a) The owner or occupier of the property or facility from which the host fruit originates must ensure that the host fruit is securely transported by covering with a tarpaulin, shade cloth, bin cover or other covering or contained within the covered transport vehicle so as to prevent infestation by Queensland fruit fly and spillage during transportation.

# Untreated Suspension Area host fruit on a direct journey to an end destination having no restrictions on account of Queensland fruit fly

- 4. Movement of host fruit originating within the Suspension Area and moving on a direct journey to an end destination which has no restrictions on account of Queensland fruit fly, subject to the following conditions:
  - (a) The owner or occupier of the property or facility from which the host fruit originates must ensure that the host fruit remains under secure conditions from post harvest to the time of dispatch and transport, except when impractical during packing and grading activities; and

- (b) Prior to movement, the owner or occupier of the property or facility from which the host fruit originates must ensure:
  - (i) all bins or containers and any vehicles to be used for the transportation of host fruit ("transport vehicle") are free from all plant debris and soil prior to packing and loading; and
  - (ii) the host fruit must be loaded onto or into a transport vehicle on a hard surface and not within the orchard from which the host fruit was sourced; and
  - (iii) the transport vehicle is free of all soil and plant debris after loading; and
  - (iv) the host fruit is transported under secure conditions that include:
    - (A) unvented packages or vented packages with the vents secured with mesh with a maximum aperture of 1.6mm prior to dispatch; or
    - (B) shrink-wrapped and sealed as a palletised unit; or
    - (C) fully enclosed under tarpaulins, shade cloth, bin cover or other covering which provides a maximum aperture of 1.6mm,

so as to prevent infestation by Queensland fruit fly and spillage during transportation; and

(v) the transport vehicle travels by the most direct route.

#### SCHEDULE 6 - Approved treatments for host fruit

#### **Preharvest Treatment and Inspection**

#### 1. Tomatoes:

- (a) treated preharvest with an application of dimethoate or fenthion or trichlorfon in accordance with all label directions for the control of Queensland fruit fly, and
- (b) inspected postharvest at the rate of at least 1 package in every 100 or part thereof, and found free of fruit fly larvae and free of broken skin.

#### 2. Capsicums and chillies:

- (a) treated preharvest with an application of dimethoate in accordance with all label directions for the control of Queensland fruit fly, and
- (b) inspected postharvest at the rate of at least 1 package in every 100 or part thereof, and found free of fruit fly larvae and free of broken skin.

#### 3. Stonefruit:

- (a) treated preharvest with an application of fenthion in accordance with all label directions for the control of Queensland fruit fly; and
- (b) inspected postharvest at the rate of at least 1 package in every 100 or part thereof, and found free of fruit fly larvae and free of broken skin.

#### 4. Table grapes:

- (a) treated preharvest for the control of Queensland fruit fly, with a program of:
  - bait sprays with an insecticide containing 0.24 g/L spinosad as the only active constituent in accordance with all label directions; or
  - (ii) bait sprays with an insecticide containing 1150 g/L maldison as the only active constituent in accordance with all label and APVMA permit (PER12359) directions; or
  - (iii) cover sprays using an insecticide containing 550 g/L fenthion as the only active constituent in accordance with all label and APVMA permit (PER11643) directions; and
- (b) inspected postharvest where a sample of the fruit is inspected and found free of fruit fly larvae and free of broken skin.

#### **Postharvest Dimethoate Dip**

- 5. Any host fruit, excluding capsicum (hollow-fruited), chilli (hollow-fruited), cumquat and strawberries, treated with a postharvest dip using an insecticide containing 400 g/L dimethoate as its only active constituent in accordance with all label and APVMA permit (PER12074) directions; where dipping is the last treatment before packing except in the case of:
  - (a) Citrus, where a non-recovery gloss wax coating and or a compatible fungicide as specified on the label may be applied within 24 hours of treatment; and
  - (b) Pomefruit, where a non-recovery gloss wax and or a compatible fungicide as specified on the label may be applied within 3 hours of treatment.

#### **Postharvest Dimethoate Flood Spray**

- 6. Any host fruit, excluding cumquat, eggplant and strawberries, treated with a postharvest flood spray using an insecticide containing 400 g/L dimethoate as its only active constituent in accordance with all label and APVMA permit (PER12074) directions, where spraying is the last treatment before packing except in the case of:
  - (a) Citrus, where a non-recovery gloss wax coating and or a compatible fungicide as specified on the label may be applied within 24 hours of treatment; and

(b) Pomefruit, where a non-recovery gloss wax coating and or compatible fungicide as specified on the label may be applied within 3 hours of treatment.

#### **Postharvest Methyl Bromide Fumigation**

- 7. Any host fruit fumigated postharvest with a fumigant containing 1000 g/kg methyl bromide as its only active constituent in accordance with all label and APVMA permit (PER10699) directions, at the following rates:
  - (a)  $10^{\circ}\text{C} 14.9^{\circ}\text{C}$  at 48 g/m3 for 2 hours; or
  - (b)  $15^{\circ}\text{C} 20.9^{\circ}\text{C}$  at 40 g/m3 for 2 hours; or
  - (c)  $21^{\circ}\text{C} 25.9^{\circ}\text{C}$  at 32 g/m3 for 2 hours; or
  - (d)  $26^{\circ}\text{C} 31.9^{\circ}\text{C}$  at 24 g/m3 for 2 hours.

#### **Postharvest Cold Treatment**

- 8. Any appropriate host fruit treated postharvest at a temperature of:
  - (a)  $0^{\circ}$ C  $\pm 0.5^{\circ}$ C for a minimum of 14 days; or
  - (b)  $1^{\circ}\text{C} 3^{\circ}\text{C} \pm 0.5^{\circ}\text{C}$  for a minimum of 16 days (Lemons minimum 14 days).

#### THREATENED SPECIES CONSERVATION ACT 1995

#### **ERRATUM**

THE Notice of Determination under the Threatened Species Conservation Act 1995 published in the *New South Wales Government Gazette* of 8 July 2011 on pages 4835 to 4838 was incomplete. The Final Determination for Sandhill Pine Woodland in the Riverina, Murray-Darling Depression and NSW South Western Slopes Bioregions was not included. The Final Determination is now published following this erratum. The gazettal date remains 8 July 2011.

Determination to make a minor amendment to Part 3 of Schedule 1 of the Threatened Species Conservation Act

THE Scientific Committee, established by the Threatened Species Conservation Act has made a Determination to make a minor amendment to Part 3 of Schedule 1 (Endangered ecological communities) of the Act by inserting the Sandhill Pine Woodland in the Riverina, Murray-Darling Depression and NSW South Western Slopes bioregions (as described in the determination of the Scientific Committee under Division 5 Part 2) and as a consequence to omit reference to the Sandhill Pine Woodland in the Riverina, Murray-Darling Depression and NSW South Western Slopes bioregions (as described in the final determination to list the ecological community) which was published on pages 2509 to 2517 in the *NSW Government Gazette* No. 37 dated 28 March 2008. Minor amendments to the Schedules are provided for by Division 5 of Part 2 of the Act.

The Scientific Committee is of the opinion that the amendment is necessary or desirable to correct minor errors or omissions in the Determination in relation to the Thackway and Cresswell (1995) reference.

The Scientific Committee has found that:

- 1. Sandhill Pine Woodland in the Riverina, Murray-Darling Depression and NSW South Western Slopes bioregions is the name given to the ecological community dominated by *Callitris glaucophylla*, that typically occupies red-brown loamy sands with alkaline sub-soils on the alluvial plain of the Murray River and its tributaries, and on parts of the sandplain in south-western NSW. In the Riverina bioregion and the far south-western portion of the NSW South Western Slopes bioregion, the community is typically associated with prior streams and aeolian source-bordering dunes, which are scattered within an extensive alluvial clay plain dominated by chenopod shrublands. In the Murray-Darling Depression bioregion, the community occurs as scattered patches on sandhills and lunettes within an extensive aeolian sandplain dominated by woodlands of mallee eucalypts or belah. Bioregions are defined in Thackway and Cresswell (1995). Sandhill Pine Woodland is characterised by the assemblage of species listed in paragraph 2 and typically comprises an open tree canopy with a sometimes sparse, but highly variable ground layer dominated by grasses and herbs, sometimes with scattered shrubs and/or small trees. The structure and species composition of the community varies depending on disturbance history and temporal variability in rainfall.
- 2. Sandhill Pine Woodland is characterised by the following assemblage of species:

- 3. The total species list of the community is larger than that given above, with many species present in only one or two sites or in low abundance. The species composition of a site will be influenced by the size of the site, recent rainfall or drought conditions and by its disturbance (including grazing, land clearing and fire) history. The number and relative abundance of species will change with time since fire, and may also change in response to changes in fire frequency or grazing regime. At any one time, above-ground individuals of some species may be absent, but the species may be represented below ground in soil seed banks or as dormant structures such as bulbs, corms, rhizomes, rootstocks or lignotubers. The list of species given above is mainly of vascular plant species, however the community also includes micro-organisms, fungi, cryptogamic plants and both vertebrate and invertebrate faunas. These components of the community are poorly documented.
- 4. Sandhill Pine Woodland is characterised by an open tree stratum, which may be reduced to isolated individuals or may be absent as a result of past clearing. The tree layer is dominated by *Callitris glaucophylla* (White Cypress Pine), either in pure stands or with a range of other less abundant trees or tall shrubs. These may include *Acacia melvillei*, *A. oswaldii*, *Allocasuarina luehmannii* (Buloke), *Callitris gracilis* subsp. *murrayensis* (Slender Cypress Pine), *Hakea leucoptera* (Needlewood), *H. tephrosperma* (Hooked Needlewood), *Myoporum platycarpum* (Sugarwood) and *Pittosporum angustifolium* (Berrigan). A scattered shrub layer is sometimes present and may include *Dodonaea viscosa* subsp. *angustifolia*, *Enchylaena tomentosa* (Ruby Saltbush), *Sclerolaena muricata* (Black Rolypoly) and/ or *Maireana enchylaenoides* (bluebush). The groundcover is highly variable in structure and composition. It may be sparse or more continuous, depending on the history of disturbance, grazing and rainfall events. It comprises grasses, such as *Austrodanthonia caespitosa* (Ringed Wallaby Grass), *A. setacea* (Small-flowered Wallaby Grass), *Austrostipa nodosa* (a speargrass), *A. scabra* (Rough Speargrass), *Enteropogon acicularis* (Curly Windmill Grass), *Panicum effusum* and *Paspalidium constrictum*; and forbs including *Atriplex semibaccata* (Creeping Saltbush), *Einadia nutans* (Climbing Saltbush), *Erodium crinatum* (Blue Storksbill), *Oxalis perennans*, *Sida corrugata* (Corrugated Sida) and *Wahlenbergia* spp. (bluebells). The structure of the community varies depending on past and current disturbances, particularly clearing, logging, grazing and soil erosion.
- 5. Sandhill Pine Woodland shares a number of species with another endangered ecological community listed under the Threatened Species Conservation Act 1995: *Allocasuarina luehmannii* Woodland in the Riverina and Murray-Darling Depression bioregions. These two ecological communities inhabit similar soils and landforms and have similar geographic distributions. They may be distinguished on the basis of the relative abundance of their tree species and subtle differences in composition of their understorey. When tree abundance is assessed at hectare scales, *Callitris glaucophylla* is the most abundant tree species in Sandhill Pine Woodland, whereas in *Allocasuarina luehmannii* Woodland, *A. luehmannii* is the most abundant tree species. Differences in understorey composition are likely to be obscured as a result of the history of heavy disturbance throughout both communities. Vegetation with characteristics that are intermediate between Sandhill Pine Woodland and *Allocasuarina luehmannii* Woodland are covered collectively under the two Determinations.
- A number of vegetation surveys and mapping studies have been carried out in regions within which Sandhill Pine Woodland occurs. The community includes: 'Callitris glaucophylla Woodland' (Community 36) and 'Dodonaea viscosa - Callitris preissii Shrubland' (Community 37) of Smith and Smith (1990); 'Mixed Woodland, Callitris Woodland' (a subunit of map units 4 and 11) of Fox (1991); 'Callitris Mixed Woodland' (map unit 16) of Scott (1992), Porteners (1993) and Porteners et al. (1997): 'Prior Stream Remnant Woodland' (Map unit 27) of Porteners (1993); 'Callitris glaucophylla open-woodland' (Community 1c) of Westbrooke and Miller (1995) and Westbrooke et al. (1998), and Callitris glaucophylla low open-woodland' (Community 4) of Morcom and Westbrooke (1990); 'Thyridolepis mitchelliana - Themeda australis understorey remnants in open woodland' (Community 2) of Benson et al. (1997); 'Callitris Mixed Woodland' (map units 1,2,3 & 6) of Stafford and Eldridge (2000); Callitris, Yellow Box, Western Grey Box, Needlewood, Buloke (map unit 53) and Callitris Mixed Woodland (map unit 55) of Roberts and Roberts (2001); Source Bordering Sands Woodland (Community 6) of White et al. (2002); Callitris glaucophylla ± Allocasuarina luehmannii ± Alectryon oleifolius Woodland on Sandy Rises (map unit ALP017) of Horner et al. (2002); and 'Pine-Oak Woodlands on Alluvial Dunes and Plains' (map unit ALP017) and 'Pine Woodlands on Dunes of the Murray Floodplain' (Map Unit FLP008) of McNellie et al. (2005). A review and classification of vegetation in western New South Wales (Benson et al. 2006) described four communities referrable to Sandhill Pine Woodland of the Riverina, Murray-Darling Depression and NSW South Western Slopes bioregions: 'Cypress Pine woodland of source-bordering dunes mainly on the Murray River floodplain' (Community 19); 'Slender Cypress Pine - Sugarwood - Western Rosewood open woodland on sandy rises of the semi-arid (warm) and arid climate zones' (Community 21); 'White Cypress Pine open woodland of sand plains, prior streams and dunes mainly of the semi-arid (warm) climate zone' (Community 28); and 'White Cypress Pine-Drooping Sheoak grassy open woodland of the Riverine Plain' (Community 48). Sandhill Pine Woodland belongs to the Riverine Sandhill Woodlands vegetation class of Keith (2004).
- 7. Sandhill Pine Woodland has been recorded in the far south-western portion of the NSW South Western Slopes bioregion near Urana, extending through the Riverina bioregion, from the Urana Narranderra district in the east, into the southern part of the Murray-Darling Depression bioregion, as far west as the South Australian border. It is currently known from the Balranald, Berrigan, Carrathool, Central Darling, Conargo, Corowa, Deniliquin, Hay, Murray, Narranderra, Urana, Wakool and Wentworth Local Government Areas, but may occur elsewhere in the Riverina, Murray-Darling Depression and NSW South Western Slopes bioregions sensu Thackway and Cresswell (1995). Throughout its distribution, the community occurs in relatively small patches, typically on red-brown sandy loams. In the Riverina and NSW South Western Slopes bioregions, these soils are associated with the beds of prior streams or source-bordering dunes adjacent to streams and lake beds, which are restricted and distinctive landforms on the extensive riverine plain. Further west,

in the Murray-Darling Depression Bioregion, the community occurs on lunettes associated with dry lake beds, and as patches within a mosaic of vegetation types on extensive sandplains.

- Vegetation mapping studies cited in Paragraph 6 allow the remaining area of Sandhill Pine Woodland to be estimated in various parts of its geographic distribution. Mapping by botanists from the National Herbarium of NSW (Fox 1992, Scott 1993, Porteners 1993, Porteners et al. 1997) covers the majority of the geographic distribution of the community, which includes map units 16 and 27 (see paragraph 6). These maps show that map units 16 and 27 have a combined extant area of approximately 85 000 ha, with an additional 86 000 ha estimated to have been cleared or degraded to 'highly disturbed' open areas, and a further 35 000 ha mapped as 'scattered trees' (Porteners 1993). Additional areas of these vegetation types occur as unmapped patches within mosaics containing other vegetation types. There are also additional areas of Sandhill Pine Woodland to the east of the National Herbarium study area. Mapping by White et al. (2002) shows approximately 10 000 ha of vegetation (Community 6) referable to Sandhill Pine Woodland in this area. The Deniliquin 1:250 000 map sheet is within the total area surveyed by Fox (1992), Scott (1993), Porteners (1993) and Porteners et al. (1997). The Deniliquin sheet includes approximately 28 000 ha of the total 85 000 ha of map units 16 and 27, 11 000 ha of the total 35 000 ha of these units mapped as scattered trees and 68 000 ha of the total 86 000 ha of map units 16 and 27 estimated to have been cleared (Porteners 1993). More recent mapping on the Deniliquin 1:250 000 map sheet (McNellie et al. 2005) shows approximately 13 000 ha of map units referable to Sandhill Pine Woodland (ALP017 and FLP008). The smaller area of mapped vegetation referable to extant Sandhill Pine Woodland by McNellie et al. (2005) than by Porteners (1993) may be partly due to a more narrow interpretation of pine-dominated woodlands by the former authors, but may also reflect a decline in area of the community.
- 9. Sandhill Pine Woodland has undergone a large reduction in its geographic distribution as a consequence of clearing for cropping and pasture improvement (Grant 1989, Smith and Smith 1990, Scott 1992, Porteners 1993, Benson *et al.* 2006). This has occurred within a time span appropriate to the life cycle of the dominant species of the community, with much of the clearing taking place between 1880 and 1910 (Grant 1989). Some clearing for cereals and irrigated agriculture has occurred later in the twentieth century (DEC *in litt.*). A recent synthesis of available map data indicates that the distribution of this community has been reduced by 40 75 % (Mackenzie and Keith 2007a). Fragmentation of the remaining stands is likely to have resulted in a large reduction in the ecological function of the community due to the small population sizes of many constituent species, enhanced risks from environmental stochasticity, disruption to pollination and dispersal of fruits or seeds, and likely reductions in the genetic diversity of isolated populations (Young *et al.* 1996, Young & Clarke 2000). The geographic distribution of the community continues to decline as a consequence of small-scale clearing (Sluiter *et al.* 1997). 'Clearing of native vegetation' is listed as a Key Threatening Process under the Threatened Species Conservation Act 1995.
- 10. Most of the stands of Sandhill Pine Woodland that have escaped broad-scale clearing have been maintained as sources of timber, either in state forests or on private land. Logging of cypress pines for construction of fences and buildings has resulted in significant changes in the structure of vegetation in these remnants, indicating a large reduction in the ecological function of Sandhill Pine Woodland. As a consequence, many contemporary stands lack large old trees and, where tree recruitment has been limited by grazing, trees in other size classes may have been reduced in density or may have been eliminated altogether. Conversely, abundant regeneration of *C. glaucophylla* has occurred after logging at some sites when there has been a temporary reduction in numbers of livestock, feral rabbits and goats. This results in relatively dense even-aged stands of trees that have yet to attain the mature structure of the community. The structure of these dense even-aged stands contrasts markedly with that of some remnants in pastures, in which large senescent trees are the only remaining size class of trees present, as a result of the continual removal of regeneration by grazing animals (Mackenzie and Keith 2007b).
- 11. Most of the remaining stands of Sandhill Pine Woodland are degraded by overgrazing, which has resulted in simplification of community structure, changes in species composition, invasion of weeds and soil erosion (Stafford and Eldridge 2000). Overgrazing by domestic livestock and feral herbivores, including rabbits and goats, has resulted in a scarcity of woody understorey plants and a lack of regeneration of palatable trees and shrubs (Scott 1992, Porteners 1993, Benson et al. 2006). Consequently, senescent trees are not replaced with new individuals and there is a prolonged trend of stand degeneration. This is particularly evident in stands of Sandhill Pine Woodland in the western areas of its distribution in the Murray-Darling Depression bioregion (Scott 1992, Porteners et al. 1997, Mackenzie and Keith 2007b). Overgrazing also reduces structural complexity, plant species diversity and habitat suitability for vertebrate fauna of the community. The sandy-textured soils of Sandhill Pine Woodland are particularly sensitive to erosion when de-stabilised as a result of trampling by hooved animals and burrowing by rabbits (Semple 1987, Eldridge 1998, Eldridge and Greene 1994). These impacts are exacerbated under drought conditions. Lunettes that support Sandhill Pine Woodland are particularly vulnerable to erosion after overgrazing because their relatively steep slopes predispose them to erosion by water during and after rainfall events, as well as by wind. Collectively, the processes associated with overgrazing have resulted in a large reduction in the ecological function of the community. 'Competition and grazing by the feral European Rabbit, Oryctolagus cuniculus' and 'Competition and habitat degradation by Feral Goats, Capra hircus' are listed as Key Threatening Processes under the Threatened Species Conservation Act 1995.
- 12. Fragmentation, grazing and small-scale physical disturbance have resulted in weed invasion throughout the distribution of Sandhill Pine Woodland, which continues to threaten the ecological function of the community. Principal weed species include:

Examples of Sandhill Pine Woodland have been recorded from Kalyarr, Mallee Cliffs, Mungo, Oolambeyan and Willandra National Parks, and Tarawi Nature Reserve (Morcom and Westbrooke 1990, Westbrooke and Miller 1995, Roberts and Roberts 2001, Porteners 1998, Benson *et al.* 2006). However, some of these reserves contain only a few hectares of the community, and all exhibit signs of degradation associated with past land uses and the continuing impacts of feral herbivores. Examples of Sandhill Pine Woodland with a diverse and healthy understorey that retain its native shrub component and contain a low abundance and diversity of weed species, are extremely rare in the region (Stafford and Eldridge 2000, DEC *in litt.*).

- 14. Sandhill Pine Woodland of the Riverina, Murray-Darling and NSW South Western Slopes bioregions is not eligible to be listed as a critically endangered ecological community.
- 15. Sandhill Pine Woodland of the Riverina, Murray-Darling Depression and NSW South Western Slopes bioregions is eligible to be listed as an endangered ecological community as, in the opinion of the Scientific Committee, it is facing a very high risk of extinction in New South Wales in the near future, as determined in accordance with the following criteria as prescribed by the Threatened Species Conservation Regulation 2002:

#### Clause 25

The ecological community has undergone, is observed, estimated, inferred or reasonably suspected to have undergone or is likely to undergo within a time span appropriate to the life cycle and habitat characteristics of its component species:

(b) a large reduction in geographic distribution.

#### Clause 27

The ecological community has undergone, is observed, estimated, inferred or reasonably suspected to have undergone or is likely to undergo within a time span appropriate to the life cycle and habitat characteristics of its component species:

(b) a large reduction in ecological function,

as indicated by any of the following:

(d) change in community structure

- (e) change in species composition
- (f) disruption of ecological processes
- (g) invasion and establishment of exotic species
- (h) degradation of habitat
- (i) fragmentation of habitat

Proclamation No. 571

Proclamation to Declare that Certain Diseases in Stock are Subject to Provisions of the Act

HER Excellency Professor Marie Bashir, Companion of the Order of Australia, Commander of the Royal Victorian Order, Governor of the State of New South Wales in the Commonwealth of Australia.

- I, Professor Marie Bashir, A.C., C.V.O., Governor of the State of New South Wales, with the advice of the Executive Council:
- 1. pursuant to section 3 (2) (a) of the Stock Diseases Act 1923 ('the Act'), revoke Proclamation No. 570 published in *New South Wales Government Gazette* No. 43 of 3 May 2011 at pages 2735-2738 and any Proclamation revived as a result of its revocation; and
- pursuant to section 4 (a) of the Act declare that the diseases specified in Column 1 of the Schedule, being diseases in stock, are diseases in respect of which the provisions of the Act or only such provisions of the Act as are specified in Column 2 of the Schedule, apply.


