# PLANT DISEASES (TREATMENT AND ERADICATION OF QUEENSLAND FRUIT FLY, RIVERINA) ORDER 2011

# under the Plant Diseases Act 1924

I, KATRINA HODGKINSON, M.P., Minister for Primary Industries, in pursuance of section 5A of the Plant Diseases Act 1924, for the purpose of treating the pest Queensland fruit fly and preventing its spread, and for the purpose of eradicating or lessening the risk of Queensland fruit fly being harboured in the Riverina, make the following Order.

# 1. Name of Order

This Order is the Plant Diseases (Treatment and Eradication of Queensland Fruit Fly, Riverina) Order 2011

# 2. Commencement

This Order commences on the date it is published in the NSW Government Gazette.

# 3. Definitions

In this Order:

Queensland fruit fly means the pest Bactrocera tryoni (Froggatt).

the Act means the Plant Diseases Act 1924.

the Riverina means the area specified in Schedule 1 to this Order.

Note: Department, inspector, occupier and owner all have the same meaning as in the Act.

# 4. Measures to prevent the spread of the pest Queensland fruit fly

Pursuant to section 5A of the Act owners and occupiers of all land or premises located within the Riverina on which are growing any plants specified in Schedule 2 to this Order must take the following measures to prevent the spread of the pest Queensland fruit fly:

(a) Treat the plants in accordance with one of the bait spray programs specified in Schedule 3 to this Order,

- (b) Maintain a record of all such treatments, and
- (c) Make the record of treatments available to an inspector upon request.

# **SCHEDULE 1 – The Riverina**

The Local Government Areas of Narrandera, Griffith, Leeton, Carrathool and Murrumbidgee.

# **SCHEDULE 2 – Plants**

All cultivars of the genus Citrus and Vitis.

All cultivars of the species Prunus domestica.

# SCHEDULE 3 – Fruit fly bait spray programs

- 1. A registered insecticide plus protein autolysate extract is applied to plant foliage as a spot spray from a backpack spray unit or a powered spray unit.
  - Note: The registered insecticide is Hy-Mal® that has the active constituent maldison. The protein autolysate extract is Pinnacle® or Natflav 500®. This pesticide is to be used in accordance with the Hy-Mal® label directions for "Fruit Fly Lure Eradication only."
- 2. Naturalure® Fruit Fly Bait Concentrate, a protein and sugar based bait containing the active constituent spinosad, is applied to plant foliage as a spot spray from a backpack spray unit.
  - Note: The registered pesticide is to be used in accordance with the Naturalure® label directions for use for the control of fruit flies.



- 3 Authority to take uncontrolled flows
  - 3.1 The holders of regulated river (general security) access licences:
    - a. with share components that specify the Bega and Brogo Regulated Rivers Water Source; and
    - b. which nominate a metered work in the Bega and Brogo Regulated Rivers Water Source;

are authorised to take water from uncontrolled flows which arise from unregulated inflows to that water source that have not been credited to the water allocation account for a regulated river (general security) access licence.

- 3.2 Water may only be taken in accordance with announcements made by the Minister for the taking of water from uncontrolled flows in the following sections of the water source only:
  - a. river reach 1A;
  - b. river reach 1B;
  - c. river reach 1C; and
  - d. river reach 2.
- 3.3 Water may only be taken using a metered work.

13 May 2011

- 3.4 Within 7 days of ceasing to take water from uncontrolled flows, regulated river (general security) access licence holders must supply State Water with meter readings taken immediately prior to and after the taking of uncontrolled flow.
- 3.5 The water sharing provisions of the Water Sharing Plan for the Bega and Brogo Rivers Area Regulated, Unregulated and Alluvial Water Sources 2011 that provide for the taking of water from uncontrolled flows are set out in Schedule 1.
- 4 Interpretation
- In this order:
  - a. metered work has the same meaning as under section 91I (4) of the Water Management Act 2000; and
  - b. river reach 1A, 1B, 1C and 2 have the same meaning as in the Water Sharing Plan for the Bega and Brogo Rivers Area Regulated, Unregulated and Alluvial Water Sources 2011.

### Schedule 1

Water sharing provisions that provide for the taking of water from uncontrolled flows

Water Sharing Plan for the Bega and Brogo Rivers Area Regulated, Unregulated and Alluvial Water Sources 2011

- 61 Taking of uncontrolled flows under regulated river (general security) access licences
  - This clause provides for the taking of water from uncontrolled flows in accordance with an order made under section 85A of the Act.
  - (2) An order under section 85A of the Act may authorise the taking of water from uncontrolled flows that arise from unregulated inflows to the Bega and Brogo Regulated Rivers Water Source that have not been credited to the water allocation account for a regulated river (general security) access licence:
    - (a) with a share component that specifies the Bega and Brogo Regulated Rivers Water Source; and(b) which nominates a metered work.
  - (3) The following rules apply to the taking of uncontrolled flows that arise from unregulated inflows to the water source specified in subclause (2):
    - (a) water may only be taken from uncontrolled flows in accordance with announcements made by the Minister. Announcements may be made by the Minister for the taking of water from uncontrolled flows in the following sections of the water source only as defined in Schedule 7:
      - (i) river reach 1A;
      - (ii) river reach 1B;
      - (iii) river reach 1C; and
      - (iv) river reach 2;
    - (b) water may only be taken from uncontrolled flows using a metered work;
    - (c) the taking of water from uncontrolled flows in river reach 1A is only permitted to commence when:
      - (i) the discharge over the Brogo Dam spillway in the immediately preceding 24 hour period has been in excess of 50 ML/day on a rising river and 20 ML/day on a falling river; or

- (ii) a discharge through the control valves of the Brogo Dam in the immediate preceding period has prevented a spillage over the spillway;
- (d) the taking of water from uncontrolled flows in river reach 1B is only permitted to commence when the conditions specified in paragraph (c) have been satisfied and the flows at the North Brogo gauge (219013) have exceeded 50 ML/ day for at least 24 hours on a rising river and 20 ML/day on a falling river;
- (e) the taking of water from uncontrolled flows in river reach 1C is only permitted to commence when the flow is sufficient to ensure that the flows at the Angledale gauge (219025) exceed 50 ML/day for at least 24 hours on a rising river and 20 ML/day on a falling river;
- (f) the taking of water from uncontrolled flows in river reach 2 is only permitted to commence when:
  - (i) the river flows at the Angledale gauge (219025) have exceeded 50 ML/day for at least 24 hours on a rising river and 20 ML/day on a falling river; or
  - (ii) the flows at the Kanoona gauge (219032) have exceeded 65 ML/day for at least 24 hours.
- (4) In any uncontrolled flow event, total extraction of uncontrolled flow under subclause (2) in each section of the water source specified in subclause (3)
  (a) under regulated river (general security) access licences must not exceed an amount that is equal to 50% of the uncontrolled flow event volume.
- (5) Announcements providing access to uncontrolled flows in the Bega and Brogo Regulated Rivers Water Source, may only occur when flows are in excess of those necessary to satisfy the system operation rules specified in clause 33 and the volume required to supply water for basic landholder rights and higher priority access licences in the Bega and Brogo Regulated Rivers Water Source.
- (6) Access to uncontrolled flows must be shared in proportion to the share component of each regulated river (general security) access licence.
- (7) In any water year, the total amount of uncontrolled flow that may be taken under each regulated river (general security) access licence is limited to an amount that is equal to the difference between:
  - (a) the sum of available water determinations for that water year for regulated river (general security) access licences; and
  - (b) the maximum sum of available water determinations that can be made for regulated river (general security) access licences under Division 2 of Part 7 of this Plan.
- (8) Within 7 days of ceasing to take water from uncontrolled flows, regulated river (general security) access licence holders must supply State Water with meter readings taken immediately prior to and after the taking of uncontrolled flow.

- (9) If the total amount of uncontrolled flow taken under an access licence exceeds the limit specified in subclause (7), then a volume equivalent to the exceedance must be debited from the water allocation account for the access licence in that water year.
  - Note It is possible for the limits specified in subclause (7) to be exceeded if available water determinations increase after uncontrolled flows have been taken.

This Petition concerns the election for the New South Wales Legislative Council held on 26th March 2011 pursuant to the Writ of Election for the Legislative Council issued on the 5th March 2011. It is brought pursuant to the *Parliamentary Electorates and Elections Act* 1912 ("the Act"). The election was for the New South Wales Legislative Council and related to the whole of New South Wales and no specific Electoral District. The Petitioner also seeks to rely upon the Common Law of Elections.

## Return of Writ

The Writ of Election for the Legislative Council was returned on 13th April 2011.

## Entitlement to file this petition

The petitioner is entitled to file this petition because she was a candidate and contested the election for the New South Wales Legislative Council held on 26th March 2011. She was not returned as elected and has a grievance with the ballot sorting,

classification and counting process which resulted in valid votes cast for her not being included in the ballot tally.

## PETITION

# To the Court of Disputed Returns:-

## Statement of facts

- The Petitioner disputes the validity of the election of the First Respondent and the Second Respondent and relies on the facts as set out in the following paragraphs to invalidate that election.
- 2. The Petitioner is an individual and an Australian Citizen.
- The Petitioner was a candidate and contested the election for the New South Wales Legislative Council held on 26th March 2011.
- 4. The First Respondent since the election has married and changed her name to Sarah Mitchell.
- An election for members of the Legislative Council of New South Wales was held on 26th March 2011 pursuant to the said writ.
- 6. The Petitioner's name was in 'Group J' on the ballot paper.
- 7. The writ was for the election of 21 members of the Legislative Council.
- 8. There were 4,635,810 electors enrolled in NSW at the time of the election.
- 9. 4,306,285 persons voted at the election for the Legislative Council.
- 10. There was two ways electors could cast their vote on the Legislative Council ballot paper, either by voting above or below the line. The line divides the ballot paper into a top section of groups, and a bottom section of the candidates within those groups, which includes an additional column for ungrouped candidates.
- 11. The initial scrutiny of Legislative Council ballot papers is done in the polling places on election night, where the ballot papers are sorted to ascertain the number of above-the-line votes for each group. Blank ballot papers are isolated and counted and all other ballot papers reported in the Other category.
- 12. The Legislative Council ballot papers are finally counted at the NSW Electoral Commission's Central Count Centre at Riverwood, NSW.
- 13. The ballot papers arrive at the Central Count Centre at Riverwood having been sorted within each polling place by those marked above the line; those marked below the line; those that are blank and those in the other category.
- 14. Unissued ballot papers are also accounted for.

- 15. According to the 'Final Count- First Preferences by Group and Candidate' results published by the NSW Electoral Commission, there were a total of 230,261 informal votes which included blank ballot papers cast as votes. There being a total of 4,306,285 votes cast. The Petitioner receiving 20,004 votes in her own name and a further 77,926 votes for Group J.
- 16. There are unexplained discrepancies in relation to the number of 'blank votes' between the final result and an earlier progress result published by the NSW Electoral Commission as being the 'Statewide Summary Progressive First Preference Group Vote' wherein there was 155,207 'blank votes' and 188,032 Other (including informal) making a total of 343,239 informal votes (as contrasted with 230,261 informal votes in the final result including the blank votes) and there was a total of 4,292,224 votes cast (presumably including postal votes & overseas posts).
- 17. Certain persons being electors entitled to vote in the election cast valid votes for the Petitioner and those votes were not included in the tally count of valid votes for the Petitioner and the failure to include those votes has affected or may have affected the result of the election.
- 18. The Petitioner became aware during the sorting and processing of ballot papers that there were instances of valid votes for her which had been incorrectly sorted into the 'blank pile' (that is blank ballot papers cast as votes by electors) before the votes were counted and not being included in the tally.
- 19.At approximately 2pm on Sunday 3<sup>rd</sup> April 2011 a scrutineer was positioned at table 17 observing the checking of blank ballot papers from the East Hills Division, Padstow Public School Polling Booth. During a check of what purported to be a bundle of fifty blank ballot papers, more than 30% of the bundle was found to contain valid votes for "Group J". The matter was reported by a table worker named William, to a supervisor.
- 20. This matter was reported to the NSW Electoral Commissioner on behalf of the Petitioner. The NSW Electoral Commission did not deny the allegation.
- 21. The Petitioner later became aware from a different source that the NSW Electoral Commission knew about the incorrect sorting of valid votes for her (Group J) into the 'blank pile' and that it was thought that at least 1,200 votes could be involved.

22.On 13 April 2011 the Petitioner received a copy of an internal NSW Electoral Commission email that is attributed to an officer of the NSW Electoral Commission communicating with a second officer to the effect:

"Thank you for your enquiry regarding advice on media enquires relating to today's pushing of the button for the Upper House preferences. Just stonewall them as much as possible when it comes to Hanson and her issues with the count. Do not mention that there is any possible provision for a recount. We know some of her people and the media are looking at the blank ballots and are trying to get them all rechecked because one of her scrutineers was meant to of found some of her votes in amongst the blanks (I have heard through the chain that there could be as many as 1200 across the state that are in with the blanks as there were a few dodgy electoral staff on, but don't offer that)."

- 23. The Petitioner believes that the email is authentic. She is aware that at least 1,200 valid formal primary votes for her were incorrectly sorted into the blank pile and/or the other pile thus reducing her total formal primary vote.
- 24. In relation to the said incorrectly sorted valid formal primary votes, those formal ballot papers were determined to be informal ballot papers contrary to the provisions of s 129F of the Act.
- 25. The proportional representation voting system is used to count the votes, which aims to allocate seats in the Legislative Council in proportion to the votes cast, once a certain quota has been reached. The process includes random sampling with votes being redistributed such that a small variance in the number of primary votes would have a magnified effect on the overall outcome after the distribution of preferences.
- 26. In the circumstances, the failure to properly count the formal primary vote for the Petitioner would have had an effect on the distribution of preferences such that the result of the election has been affected or may have been affected.
- 27. The Petitioner does not dispute the election of the first 19 candidates returned.
- 28. The NSW Electoral Commissioner, the Returning Officer for the Legislative Council election, on the 13th April 2011 declared the result of the counting for the said election and declared that Jeremy Buckingham was elected to the 20th seat and Sarah Johnston elected to the 21st and final seat.
- 29. The said Returning Officer did by endorsement on the said writ certify Jeremy Buckingham and Sarah Johnston as two of the duly elected members to serve in

the Legislative Council for New South Wales and returned the writ on 13th April 2011 so endorsed to Her Excellency the Governor.

- 30. The Petitioner received more primary votes than Jeremy Buckingham and Sarah Johnston.
- 31. The Petitioner received 2.41% of the state-wide votes.
- 32. The Petitioner was unsuccessful in the election after the distribution of preferences was announced by the NSW Electoral Commissioner on the 13th April 2011.
- 33.After the 17th count of votes when allocating preferences, Niall Blair was distributed as a successful candidate for the seventeenth seat leaving four seats to be distributed.
- 34.As at the 18th count of votes during the allocation of preferences Jeremy Buckingham had 80,171 votes, Sarah Johnston had 87,385 votes and the Petitioner had 98,393 votes.
- 35. Following the 308th count, the candidates Jeremy Buckingham, Sarah Johnston, Robert Green and Paul Green were returned as elected after the Petitioner was excluded after the allocation of preferences based on the then primary vote count, which excluded the valid votes that the Petitioner asserts had been incorrectly sorted or incorrectly classified.
- 36. After the final allocation of preferences Jeremy Buckingham had 105,472 votes and Sarah Johnston 104,341 and the Petitioner 103,035.
- 37. The Petitioner asserts that if the formal primary votes as cast were properly sorted and counted then she would have been elected to the New South Wales Legislative Council.

## RELIEF

The Petitioner prays that:

- This Court grant leave under section 171 of the Act for David Leamey, Solicitor to represent the Petitioner and that he be permitted to instruct William Peter Lowe of Counsel to appear on behalf of the Petitioner.
- 2. The NSW Electoral Commissioner retain the ballot papers until after the determination of this Petition.

- 3. The NSW Electoral Commissioner provide discovery of all reports, documents and emails in his possession or control involving the issue of Pauline Hanson votes being sorted or classified into the 'blank pile' or informal pile.
- 4. That personal service on the First and Second Respondents be dispensed with and that they be served at their respective Party's NSW office.
- 5. That the NSW Electoral Commissioner in the presence of representatives of the Petitioner make the 'blank pile' of ballot papers; the informal pile of ballot papers; and the unissued pile of ballot papers available for inspection and verification that they have been properly classified and to verify that there has been no tampering or unauthorised use of the unissued ballot papers.
- That the results of the verification in the previous prayer be reported to the Court.
- 7. That the process of the distribution of preferences for all candidates be done again by the NSW Electoral Commissioner after correcting the primary vote tally by adding the number of any valid votes found in the 'blank pile' or the informal pile to the primary vote tally with the result being notified to this Court.
- 8. A declaration that either Sarah Johnston or Jeremy Buckingham was not duly elected as a member of the Legislative Council of New South Wales at the election held on 26 March 2011.
- 9. A declaration that the Pauline Lee Hanson was duly elected as a member of the Legislative Council of New South Wales at the election held on 26 March 2011.
- 10. That the NSW Electoral Commissioner cause the recall of the writ from Her Excellency the Governor and endorse on it any amendments to the duly elected members of the Legislative Council of New South Wales so as to reflect any declarations made by the Court.

- 11. Costs pursuant to section 172 of the Act or, in the alternative, the Petitioner's costs be paid by the NSW Electoral Commissioner.
- 12. All other parties pay their own costs.
- 13. Such further or other orders as the nature of the proceedings may require or as appropriate in accordance with the Act or the common law of elections.
