Catch Limits for Certain Dogfishes (Deepwater Sharks)

I, PAUL O’CONNOR, Principal Director, Fisheries & Compliance, with the delegated authority of the Minister for Primary Industries and the Director-General of the Department of Industry and Investment pursuant to sections 227 and 228 of the Fisheries Management Act 1994 (“the Act”), do by this notification pursuant to section 8 of the Act prohibit the taking of Harrison’s Dogfish (*Centrophorus harrissoni*), Endeavour Dogfish (*Centrophorus moluccensis*), Greeneye Spurdog (*Squalus chloroculus*) and Southern Dogfish (*Centrophorus zeehaani*) from ocean waters by the methods of fishing specified in Column 1 of Schedule 1 to this notification, by holders of endorsements in the Ocean Trap and Line Fishery and the Ocean Trawl Fishery, except when those fish are taken in accordance with the conditions specified in Column 2 of Schedule 1 to this notification.

Explanatory Note

Clause 94 of the Explosives Regulation 2005 provides that the regulatory authority may, by order published in the Gazette, exempt any class of persons or things from a specified provision of the Regulation. This Order exempts from clauses 15 (2) (the requirement for the mine operator (for the avoidance of doubt) to hold a licence for the storing of an explosive or an explosive precursor), on Mine sites, subject to conditions.

Explosives Regulation 2005 Exemption Order No. 007/11

1. Name of Order

This Order is the Explosives Regulation 2005 Exemption Order No. 007/11

2. Commencement

This Order commences on the date that it is published in the *New South Wales Government Gazette*, and has effect for a period of five years from that date.

3. Exemption

Mines using the services of a contractor to conduct aspects of drill and blast services, which includes the storing of explosives or explosive precursor, are exempt from the provisions of clauses 15 (2), (insofar as clause 15 (2) requires licensing of the storage on a mine site to be undertaken by the mine operator), of the Explosives Regulation 2005.

Granting of the above exemption is subject to the following conditions:

- (a) The Mine operator must have in place a contractual agreement with the contractor, specifying the requirements of safe and secure storage of explosives and or explosive precursors. The mine operator must ensure that these requirements are strictly followed. These procedures must be detailed and specific to the particular mine site and must be able to demonstrate equivalent levels of safety and security to the requirements of the Regulation
- (b) The mine operator must ensure that the licence held by the contractor under the explosives regulation remains current.
- (c) The mine operator must hold a current copy of the contractor's security plan and ensure the procedures and measures outlined within the document are consistent with mine operations.

4. Definition

In this Order:

'Contractor means' drill and/or blast and/or explosive services provided to a mine by an outsourced service. The contractor has the total responsibility to the

mine site for providing the storage and security of explosives and explosives precursors on the mine site.

Please note: Under clause 95 of the Regulation, a Register of Exemptions must be kept by WorkCover NSW and be available for public inspection upon request
