



This Notification is the Aquatic Reserves Notification 2013.

#### 2. Commencement

This Notification commences on 1 September 2013.

#### 3. Revocation of previous notification

The notification titled "Section 197E – Aquatic Reserve Notification" dated 14 September 2011 and published in the *Government Gazette* No. 91 dated 16 September 2011 at page 5570 is revoked.

#### 4. Prohibition of activities

The activities specified in Column 2 of Schedule 1 are prohibited in the aquatic reserves specified opposite in Column 1 of Schedule 1.
