NOTE: Advance notice of a Special Supplement is essential as early as possible on the day required. On Thursdays early notice is a priority and when possible notice should be given a day prior being the Wednesday.

Notice of Proposed Alterations of Electoral Districts

THE Electoral Districts Commissioners give notice that it is proposed to alter the electoral districts of New South Wales. The proposed names, outline maps and links to the official boundary data of the new electoral districts are published in the Appendix.

A written statement of the Commissioners' reasons for making the proposed alterations is also available for inspection, at no cost, at the Redistribution website www.redistribution.nsw.gov.au and at the office of the Commissioners during office hours.

Any person or organisation may make suggestions or objections in relation to any of the proposed electoral districts. Any such suggestions or objections will be received by the Commissioners until Wednesday, 17 July 2013.

The Commissioners will consider any suggestions or objections lodged with them before determining the names and boundaries of electoral districts.

Any person or organisation that wishes to make an oral submission to the Commissioners must indicate such at the time of making their suggestions or objections.
