About this annual report

This annual report documents the activities of Jobs for NSW from 1 July 2018 to 30 June 2019 and reflects the aims and structure of the organisation as it was during that time.

Following the re-appointment of NSW Premier Berejiklian and her new Cabinet in April 2019, the NSW Government changed the Machinery of Government (MoG).

On 1 July 2019:

- The NSW Department of Industry, Skills and Regional Development became part of the NSW Department of Planning, Industry and Environment;
- The former NSW Department of Industry was abolished; and
- Jobs for NSW functions became part of NSW Treasury.

These changes were in accordance with Administrative Arrangements (Administrative Changes—Public Service Agencies) Amendment Order 2019.

The MoG changes meant that an independent board was no longer necessary. As a result, the independent members of the Jobs for NSW Board formally resigned on 24 May 2019.

The current board consists of Mr Michael Pratt, Secretary of NSW Treasury and Mr Tim Reardon, Secretary of the NSW Department of Premier and Cabinet.

Also as part of MoG, a review of the functions of Jobs for NSW was initiated by NSW Treasury, with applications for its grants, loans and other financial products being paused. Since this time, applications for the popular Minimum Viable Product Grant, which provides up to \$25,000 funding for pre-revenue startups, have resumed.

About Jobs for NSW

Jobs for NSW is a statutory body set up in September 2015, under the *Jobs for NSW Act;* supporting startups, and emerging and fast-growth small to medium sized enterprises (SMEs), to scale and grow new jobs across the state of NSW.

The organisation is committed to supporting innovative businesses, while building a strong and supportive ecosystem in NSW, by creating financial programs to help eligible organisations prosper and become the job-creating powerhouses of the future.

Jobs for NSW plays a role in developing and maintaining the NSW economy by:

- facilitating the creation of new jobs in a way that responds to changes in the economy;
- fostering the development and attraction of new businesses, and the consolidation of existing businesses in NSW;
- using high level private sector business experience to strategically advise government for the purpose of creating jobs and driving investment; and
- provisioning innovative, cost-effective and strategically targeted incentives for economic development.

Through strategic investments and other related programs, Jobs for NSW provides innovative and sustainable approaches to accelerate job creation across the state.

With \$190 million allocated, initially over a four-year period (from 28 September 2015 to 30 June 2019), the Jobs for NSW Fund has committed financial obligations beyond 2022. The Fund has offered a suite of financial products, consisting of grants, loans, and loan guarantees to support industries and entrepreneurial businesses generate sustainable jobs across the state.

During this time, in excess of 700 companies received funding, with over 300 of those organisations successfully receiving loans and grants during the 2018-2019 financial year.

Jobs for NSW support for business

The Jobs for NSW Fund caters to three different areas:

- 1. Startup Support
- 2. Emerging Business Support
- 3. Regional Support

Startup Support

Catering to promising NSW startups, there are two financial support packages available for eligible businesses.

Minimum Viable Product (MVP) grants

Designed to support startups that are not yet generating revenue; they provide up to \$25,000 to gather customer feedback and test the organisation's business model to ensure success.

In addition, Jobs for NSW also offers a travel stipend of \$2,000 to assist regional startups that are successful in the MVP grant, funding entrepreneurs to travel within NSW and to Sydney to support their business and share their successes.

Building Partnerships grants

Help revenue generating startups, and SMEs, scale or grow strategically through the acquisition of a key customer or channel to market. Eligible businesses receive up to 35 percent of the project costs, up to a maximum grant of \$100,000.

Emerging Business Support

Emerging, and fast-growth SMEs, experiencing strong progress, can be entitled to a range of support and funding initiatives to help them reach their potential. These include:

Accelerating Growth Loans

Provides direct finance for SMEs who are creating jobs in metro Sydney, Newcastle or Wollongong between the value of \$200,000 and \$500,000.

Strategic Growth Loans

Provides direct loans over \$500,000 to \$1.2 million, with a flexible loan structure to assist fast-growth SMEs.

Loan Guarantees

Assists fast-growth SMEs across NSW in obtaining loan approvals needed to expand. Eligible businesses could be guaranteed up to 50 percent of the loan from the financial institution (to a maximum of \$5 million).

Equity

Established enterprises may receive an equity investment from the GO NSW Equity Fund to undertake significant expansion and sustainable jobs creation.

Western Sydney Investment Attraction Fund (WSIAF)

A \$5 million fund, allocated from the Jobs for NSW Fund, focused on supercharging fast-growing SMEs in Western Sydney and attracting new high-value knowledge-based jobs and investments in the region.

Regional Support

Jobs for NSW is also committed to supporting growing regional businesses outside of metropolitan Sydney, Newcastle and Wollongong through the dedication of 30 percent of the Fund.

As at 30 June 2019, 36 percent has been apportioned to the state's regional areas, amounting to \$56.6 million, benefiting over 150 businesses in regional NSW, including the Regional Investment Attraction Fund.

Regional Investment Attraction Fund (RIAF)

A \$20 million fund allocation from the overarching Jobs for NSW Fund, designed to attract jobs and investment to regional NSW.

Regional Growth Loans

A program available to eligible businesses outside of Sydney, Newcastle and Wollongong consisting of interest free loans up to \$500,000 for fast-growth SMEs, creating at least 10 full time regional jobs within two years.

Growing the ecosystem across NSW

Jobs for NSW has spearheaded several initiatives benefiting communities and cities statewide, through the acceleration of priority industries, enabling entrepreneurism and ensuring sustainability into the future.

The activities below have been integral to fostering the growing ecosystem across the state; driving connections and furthering education by partnering and collaborating with government, educational institutions, industry bodies, funding sources such as venture capital firms and broader private sector companies.

Sydney Startup Hub (SSH)

In operation since February 2018, the SSH is at full tenancy with more than 440 startups and 1,800 individuals in residence; a result far surpassing initial year one predictions. The four anchor tenants – Fishburners, Stone and Chalk, Tank Stream Labs and The Studio - are full, with startups on waiting-lists to occupy space.

The SSH has set a precedent. The first of its kind in Australia, it has become the central point for startup activity, not only across NSW but also nationally. A stream of successful startups have emerged from the hub, attracting venture capital and angel investment.

A snapshot in time – statistics as at 30 June 2019

- More than 50,000 guests have registered at the hub
- More than 440 startups have raised more than \$200 million in capital
- The hub has attracted more than 20,000 attendees to events
- Since February 2018, these startups have created nearly 1,000 new jobs for NSW

The Regional Landing Pad

The Regional Landing Pad is a dedicated space within the Sydney Startup Hub for entrepreneurs visiting from regional NSW. It gives regional entrepreneurs a Sydney base, and provides them great accessibility to the metropolitan startup community.

Regional visitors have embraced this space, with more than 1,460 bookings (as at 30 June 2019) made since its inception.

Local Innovation Network (LIN)

A \$2.1 million commitment by the NSW Government, the network supports regional entrepreneurship and assists in the development of thriving entrepreneurial communities across NSW.

Consisting of seven centres – Armidale, Bathurst, Byron Bay, Coffs Harbour, Newcastle/Hunter region, Wollongong region and Wagga Wagga – each of them deliver support programs, run events and help entrepreneurs in their surrounding communities access the support they need.

Through this network, local businesses share success stories within their communities, while learning from other leaders in their ecosystems. The addition of online programs has enabled remote entrepreneurs to gain insights, while still directly sharing experiences, face-to-face, at events.

Importantly, the LIN program addresses some of the challenges faced by regional communities, such as building mentoring skills and providing investor training. Contacting these stakeholders brings communities together to help entrepreneurs progress.

Since September 2018, across the network, there have been more than 14,000 attendees at over 400 events.

To complement the LIN, in May 2019 Jobs for NSW kicked off its support of the grassroots NSW Regional Pitchfest. Held over eleven locations across regional and rural NSW, the initiative is designed to help realise the potential and celebrate the success of Australia's rural and regional entrepreneurs, artisans and small businesses.

Startups pitched to a live audience, and expert panel, to win a share of \$20,000 to invest in their ideas.

Regional Investment Attraction Fund

The Fund offers a range of incentives to attract new and growing businesses to regional NSW and provides assistance to Special Activation Precincts which bring together planning and investment, to focus on growing jobs and economic activity in an area.

In June 2018, Parkes in NSW's Central West was named the state's first Special Activation Precinct, taking advantage of its unique location at the intersection of the Inland Rail line.

Western Sydney

Western Sydney has been a focus of startup ecosystem development in the past year. Jobs for NSW launched the \$5 million WSIAF in October 2018 to support growing SMEs in the region, and actively drive the business community to collaborate with universities and all three levels of government through a series of educational events.

The educational events formed part of the 'How Government Can Help Your Business Grow' series. With speakers from AusIndustry, AusTrade, Department of Finance, Service and Innovation, InnovationNSW, Innovation Connections, Local Council and International, Trade and Investment (Exports), each of these events was well attended, attracting over 100 participants and generating many conversations among founders, owners and their local government counterparts.

Jobs for NSW also contributed to the strategies of the Liverpool Innovation Precinct, Campbelltown Collaboration Area and Bankstown Collaboration Area. These initiatives will drive the step-change required to grow the presence of emerging medtech and advanced manufacturing industries in Western Sydney, adding local jobs for residents.

Jobs for NSW Governance

Following the re-election of the Berejiklian Government in April 2019, and the release of the Administrative Arrangement Orders, it was announced Jobs for NSW would cease to be an independent agency, with its functions transferring from the Department of Industry Cluster into the Treasury Cluster.

With Jobs for NSW moving into NSW Treasury it was decided that an independent board was no longer necessary. The external members of the Jobs for NSW Board formally resigned effective 24 May 2019.

At this time the members of the Jobs for NSW Board were:

Due to the MoG changes, Simon Draper was appointed to the role of CEO at Infrastructure NSW and Jim Betts was named the Secretary of NSW DPIE and assumed Mr Draper's position on the Board until 30 June 2019 when Jobs for NSW formally transitioned from DPIE into NSW Treasury. Therefore Michael Pratt, Secretary of NSW Treasury attended the final Board meeting of the financial year in place of Mr Betts.

The current board consists of Mr Michael Pratt, Secretary of NSW Treasury and Mr Tim Reardon, Secretary of the NSW Department of Premier and Cabinet.

The position of CEO for Jobs for NSW was held by Geoff White in an acting capacity until 3 September 2018.

Nicole Cook joined as CEO on 3 September 2018. Nicole Cook resigned as CEO effective 16 August 2019. The operations of the Fund are now managed by the Industry, Jobs and Innovation team within NSW Treasury.

Operational Detail

At the end of June 2019, the operational structure for Jobs for NSW included 38 staff including temporary contractors.

Staff and operational expenses of Jobs for NSW are consolidated into the Department of Industry's Annual Report 2018-19.

Board meetings

The Jobs for NSW Board meetings were held every second month. During the 2018-19 financial year, a total of five meetings were held, none of which were out of session. The Board also met on two separate occasions to review funding applications as an investment committee.

Board expenses

In 2018-19, \$266,000 was spent on Board expenses, which included remuneration fees of \$226,000 paid to five Board members, covering a period of 11 months. Board members who were Crown employees are not remunerated for their services as Board members.

The remuneration of the Jobs for NSW Board was determined by the NSW Public Service Commission's guidelines outlined in the Classification and Remuneration Framework for NSW Government Boards and Committees.

Application of Jobs for NSW Fund

The Jobs for NSW Fund has an allocation of \$190 million, to provide strategically targeted incentives for economic development in NSW and to facilitate job creation.

As at 30 June 2019, Jobs for NSW had committed \$133.2 million to job creation investment opportunities and supported more than 700 businesses across NSW.

Furthermore, 36 percent of Jobs for NSW Fund has been apportioned to the state's regional areas. This has been achieved through \$37.5 million of the total Jobs for NSW Fund (including loan guarantee obligations) committed to regional NSW, and \$20 million allocated to the RIAF.

1. JOBS FOR NSW FUND INFORMATION

Fund

Jobs for NSW Fund (the Fund) is a not-for-profit of the shareholders fund (as profit is not its principal objective) and it has no cash generating units.

The Fund is constituted under the Jobs for NSW Act 2015 (the Act) and was established on 28 September 2015.

Part 3 Section 12 (1) of the Act establishes the Fund as a Special Deposits Account.

The financial report has been prepared on the basis that the Fund is not a reporting entity under the Australian Accounting Standards. The financial report of the Fund is a special purpose financial report for the year ended 30 June 2019.

The financial report for the year ended 30 June 2019 has been authorised for issue by the Executive Director on the date the accompanying Statement by Executive Director was signed.

Key activities

To facilitate the Minister in achieving the objects of the Act including administering the receipts and payments from the Fund.

Funding sources for Jobs for NSW Fund

Part 3 Section 12 (2) of the Act states the amounts payable to the Fund are:

- a) all money appropriated by Parliament for the purposes of this Act,
- b) all other money received by Jobs for NSW or by the Minister for the purposes of this Act,
- c) any fees or charges paid under this Act,
- d) all money directed or authorised to be paid into the Fund under this or any other Act,
- e) the proceeds of the investment of money in the Fund.

Payments out of Jobs for NSW Fund

Part 3 Section 12 (3) of the Act states the amounts payable from the Fund are:

- a) amounts for jobs creation incentives for proposal under this Act,
- b) the costs of administering this Act,
- c) all money directed or authorised to be paid out of the Fund under this or any other Act.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of preparation

The Fund's financial report is a special purpose financial report that has been prepared in order to account for the transactions of the Fund under the Act.

The financial report has been prepared in accordance with the significant accounting policies disclosed below. Such accounting policies are consistent with the previous year unless stated otherwise.

The statement of net assets and statement of comprehensive income have been prepared on an accruals basis and based on historic costs and do not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

All amounts are rounded to the nearest one thousand dollars and are expressed in Australian currency.

a) Accounting for Goods and Services Tax (GST)

Income, expenses and assets are recognised net of the amount of GST, except that:

- the amount of GST incurred by the Fund as a purchaser that is not recoverable from the Australian Taxation
- Office is recognised as part of the cost of acquisition of an asset or as part of an item of expense and
- receivables and payables are stated with the amount of GST included.

b) Income recognition

Income is measured at the fair value of the consideration or contribution received or receivable. Additional comments regarding the accounting policies for the recognition of income are discussed below.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

b) Income recognition (continued)

(i) Grants and Contributions

Income from grants (other than contribution by owners) is recognised when the Fund obtains control over the grant. The Fund is deemed to have assumed control when the grant is received or receivable.

Contributions are recognised at their fair value. Contributions of services are recognised when and only when a fair value of those services can be reliably determined and the services would be purchased if not donated.

The Fund's budgeted grants and contributions were included as part of the Department of Industry's budget.

(ii) Interest Income

Interest income is recognised using the effective interest rate method. The effective interest rate is the rate that exactly discounts the estimated future cash receipts over the expected life of the financial instrument or a shorter period, where appropriate, to the net carrying amount of the financial asset.

(iii) Fee Income

The Fund's fee income is derived from loan guarantees issued. The fee amount is determined by the financial institution.

Fee income is recognised as income when the Fund obtains control over the fee income. Control over the fee income is normally obtained upon the receipt of cash.

c) Grants and subsidies paid

Grants and subsidies are generally recognised as an expense when the Fund relinquishes control over the assets comprising the grants/subsidies. The Fund is deemed to have relinquished control when the grant/subsidy is paid or becomes payable.

d) Loans and receivables

Trade receivables, loans, and other receivables that have fixed or determinable payments that are not quoted in an active market are classified as loans and receivables. Loans and receivables are measured at amortised cost using the effective interest method, less any impairment. Changes are recognised in the net result for the year when impaired, derecognised or through the amortisation process.

Short-term receivables with no stated interest rate are measured at the original invoice amount unless the effect of discounting is material.

e) Payables

Payables represent liabilities for goods and services provided to the Fund and other amounts. Short-term payables with no stated interest rate are measured at the original invoice amount where the effect of discounting is immaterial.

f) Financial guarantees

A financial guarantee contract is a contract that requires the issuer to make specified payments to reimburse the holder for a loss it incurs because a specified debtor fails to make payment when due in accordance with the original or modified terms of a debt instrument.

During the reporting year the Fund issued loan guarantees to its customers as part of the job incentive program. The maximum value over the full life of the issued loan guarantees is \$9,750,000 (30 June 2018: \$6,608,589). The current loan guarantee amount as at 30 June 2019 is \$9,750,000 (30 June 2018: \$5,608,589).

Financial guarantee contracts are not recognised as a liability at the time the guarantee is issued.

The Fund has performed an assessment on its financial guarantee contracts and has concluded that the possibility of any outflow in settlement from these contracts is remote, therefore no contingent liability has been recognised at 30 June 2019. Refer to Note 5 regarding disclosures on contingent liabilities.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

g) Investments

The Fund has an interest in a joint venture which is recognised under the equity method in accordance with AASB 128 *Investments in Associates and Joint Ventures*. Under the equity method, the investment is initially recognised at cost, and subsequently adjusted to recognise the Fund's share of profit or loss in the joint venture. The share of profit or loss in the joint venture is recognised in the Fund's Statement of Comprehensive Income.

The Joint Venture, Go NSW Fund, measures its underlying financial assets and liabilities as follows:

(a) Classification - Policy effective from July 1, 2018

In the current period, the Joint Venture has adopted AASB 9 *Financial Instruments* ("AASB 9"). AASB 9 replaces AASB 139 *Financial Instruments: Recognition and Measurement* ("AASB 139") and introduces new requirements for classification and measurement, impairment and hedge accounting. AASB 9 is not applicable to items that have already been derecognised at July 1, 2018, the date of initial application.

In accordance with AASB 9, the Joint Venture classifies its financial assets and financial liabilities at initial recognition into the categories of financial assets and financial liabilities discussed below.

In applying that classification, a financial asset or financial liability is considered to be held for trading if:

- It is acquired or incurred principally for the purpose of selling or repurchasing it in the near term;
- On initial recognition, it is part of a portfolio of identified financial instruments that are managed together and for which there is evidence of a recent actual pattern of short-term profit-taking; and
- It is a derivative (except for a derivative that is a financial guarantee contract or a designated and effective hedging instrument).

(i) Financial assets

The Joint Venture classifies its financial assets as subsequently measured at amortised cost or measured at FVPL on the basis of both:

- The entity's business model for managing the financial assets.
- The contractual cash flow characteristics of the financial asset.

A financial asset is measured at FVPL if:

- Its contractual terms do not give rise to cash flows on specified dates that are solely payments of principal and interest ("SPPI") on the principal amount outstanding;
- It is not held within a business model whose objective is either to collect contractual cash flows, or to both collect contractual cash flows and sell; and
- At initial recognition, it is irrevocably designated as measured at FVPL when doing so eliminates or significantly reduces a
 measurement or recognition inconsistency that would otherwise arise from measuring assets or liabilities or recognising the
 gains and losses on them on different bases.

The Joint Venture includes in this category its investments in unlisted unit trusts and private companies.

(ii) Financial liabilities

All financial liabilities shall be classified as subsequently measured at amortised cost, except for financial liabilities at FVPL.

The Joint Venture classifies its financial liabilities as FVPL if it meets one of the following conditions:

- It meets the definition of held for trading;
- Upon initial recognition it is designated at FVPL; and
- It is designated either upon initial recognition or subsequently at FVPL.

The Joint Venture had no outstanding financial liabilities at FVPL as at June 30, 2019.

(b) Recognition/derecognition

The Joint Venture recognises financial assets and financial liabilities on the date it becomes party to the contractual agreement (trade date) and recognises changes in fair value of the financial assets or financial liabilities from this date.

Investments are derecognised when the right to receive cash flows from the investments has expired or the Joint Venture has transferred substantially all risks and rewards of ownership.

(c) Measurement

(i) Financial assets and financial liabilities at FVPL

Financial assets and financial liabilities at FVPL are measured initially at fair value excluding any transaction costs that are directly attributable to the acquisition or issue of the financial asset or financial liability. Transaction costs on financial assets and financial liabilities at FVPL are expensed immediately. Subsequent to initial recognition, all instruments at FVPL are measured at fair value with changes in their fair value recognised in the statement of comprehensive income.

- Fair value in an active market

The fair value of financial assets and financial liabilities traded in active markets is based on their quoted market prices at the statement of financial position date without any deduction for estimated future selling costs. Financial assets are priced at current bid prices, while financial liabilities are priced at current asking prices.

• Fair value in an inactive or unquoted market

The fair value of financial assets and financial liabilities that are not traded in an active market is determined using valuation techniques. These include the use of recent arm's length market transactions, reference to the current fair value of a substantially similar other instrument, discounted cash flow techniques, option pricing models or any other valuation technique that provides a reliable estimate of prices obtained in actual market transactions.

Where discounted cash flow techniques are used, estimated future cash flows are based on management's best estimates and the discount rate used in a market rate at the statement of financial position date applicable for an instrument with similar terms and conditions.

For other pricing models, inputs are based on market data at the statement of financial position date. Fair values for unquoted equity investments are estimated, if possible, using applicable pricing/earnings ratios for similar listed companies adjusted to reflect the specific circumstances of the issuer.

Investments in unlisted unit trusts are recorded at the redemption value per unit as reported by the managers of such investments. For investments in private companies where observable market prices in active markets, such as quoted values or recent comparable trades, are not available or do not exist, securities are valued using appropriate valuation techniques as reasonably determined by the managers of such investments. In completing the review of manager valuations the Investment Manager applies the International Private Equity and Venture Capital Valuation Guidelines as endorsed by the Australian Private Equity & Venture Capital Association Limited.

To the extent that the Joint Venture owns investments for which observable market prices in active markets do not exist, the amount determined to be fair value of the investment may incorporate the manager's own assumptions (including assumptions that the manager believes market participants would use in valuing the investment and assumptions relating to appropriate risk adjustments for nonperformance and lack of marketability). The methods used to estimate the fair value of such investments include the market approach and the income approach, each of which involve a significant degree of judgement. These investments, in certain instances, may also be valued at cost for a period of time after an acquisition when the manager determines it is the best indicator of fair value. Due to the inherent uncertainty of manager valuations, those estimated fair values may differ significantly from the fair values that would have been used had an active market for the securities existed, and the differences in fair value could be material.

(ii) Financial instruments at amortised cost

Financial instruments at amortised cost are measured initially at fair value plus transaction costs and subsequently amortised using the effective interest method, less impairment losses if any. Such assets are reviewed at each statement of financial position date to determine whether there is objective evidence of impairment. The Joint Venture holds only receivables with no financing component and which have maturities of less than 12 months at amortised cost and, as such, has chosen to apply an approach similar to the simplified approach for expected credit losses ("ECLs") under AASB 9 to all its receivables. Therefore, the Joint Venture does not track changes in credit risk, but instead recognises a loss allowance based on lifetime ECLs at each reporting date.

If in a subsequent period the amount of an impairment loss recognised on a financial asset carried at amortised cost decreases and the decrease can be linked objectively to an event occurring after the write-down, the write-down is reversed through the statement of comprehensive income.

The Joint Venture includes in this category its cash at bank, distributions receivable, other receivables and other payables and accruals.

(d) Offsetting financial instruments

Financial assets and financial liabilities are offset and the net amount reported in the statement of financial position if, and only if, there is a legally enforceable right to offset the recognised amounts at all times and there is an intention to settle on a net basis, or realise the asset and settle the liability simultaneously.
