Officer's Recommendation

- That Council note the information regarding the successful outcome of the Local Strategic Planning Statement (LSPS) Final Health Check held on 28 January 2020, and that the feedback of the Greater Sydney Commission (GSC) and various NSW State Government agencies has been incorporated into the Final Draft Campbelltown LSPS.
- 2. That Council endorse the Final Draft Campbelltown LSPS and its forwarding to the GSC for the purposes of seeking Assurance so that the LSPS can be made.
- 3. That Council delegate to the General Manager:
 - The ability to make minor amendments to the Final Draft LSPS (if needed), to address any changes required as part of the final Assurance process, that do not change the intent of the LSPS, and
 - b. The authority to make the Campbelltown LSPS once Assurance has been granted.

Purpose

To provide Council with an update on the progress of the LSPS preparation process, including:

- 1. An overview of the process to date
- 2. The outcomes of the GSC's Final LSPS Health Check held on 28 January 2020
- 3. The next steps in the process.

History

All councils in the Greater Sydney Region are required to prepare a Local Strategic Planning Statement in accordance with the requirements of the *Environmental Planning and Assessment Act, 1979* (EP&A Act) and the Environmental Planning and Assessment (Savings, Transitional and Other Provisions) Regulation 2017. LSPSs are required to be in place before 31 March 2020. Relevant past milestones are as follows:

11 June 2019	Council adopted the draft LSPS for exhibition.
12 June – 22 July 2019	Draft Campbelltown LSPS publicly exhibited.
2 September 2019	Council officers attended a LSPS "Preliminary Health Check" with GSC, the Department of Planning and Environment (DPIE) and Transport for NSW (TfNSW). Feedback was provided on the Draft LSPS (as exhibited).
10 September 2019	Council considered a report, which outlined the main issues raised in submissions following public exhibition of the Draft Campbelltown LSPS.
26 November 2019	Councillors were briefed on the proposed responses to matters raised at the LSPS "Preliminary Health Check" and to the issues raised following exhibition of the Draft Campbelltown LSPS.
10 December 2019	Council considered a detailed report on the issues raised in submissions and feedback from the GSC and Government. Council resolved to endorse preparation of the Revised Draft LSPS and its lodgement with the GSC for the purposes of the Final Health Check.
21 January 2020	The Revised Draft Campbelltown LSPS and supporting documentation was lodged with the GSC.
28 January 2020	Final LSPS Health Check Meeting with the GSC and Government Representatives.

Report

1. Background

The Revised Draft Campbelltown LSPS is Council's plan for its community's social, environmental and economic land use needs over the next 20 years. It provides a policy and spatial context and direction for land use decision making within Campbelltown LGA. The Revised Draft LSPS includes:

- a 20 year land use vision for the Campbelltown LGA aimed at positioning Campbelltown as Greater Sydney's Lifestyle Capital
- four planning themes, 16 planning priorities and a range of actions to achieve our future vision
- discussion of the characteristics that make our city special, unique and vibrant, and shared values to be enhanced or maintained
- direction for the management of future growth and change
- guidance to inform changes to Campbelltown LEP 2015 and Council's Development Control Plans

- content, priorities and actions that give effect to the Region and District Plans, as relevant to the Campbelltown LGA, at the local level, and
- identification of where further detailed strategic planning may be needed.

The Revised Draft Campbelltown LSPS responds to Region and District planning initiatives and to what our community has told us is important for the future of our city. It seeks to achieve a balance between NSW Government directives and community concerns.

2. Final Health Check of Campbelltown LSPS by Greater Sydney Commission

The General Manager, Director City Growth, Acting Director City Development, and 14 Senior Council Officers attended the Final LSPS Health Check Meeting with the GSC and Government on 28 January 2020.

The purpose of the Final Health Check was to assess the alignment of the Revised Draft Campbelltown LSPS with the Western City District Plan and particularly the District Plan's priorities and actions. The GSC and Government expressed their overall support for the Revised Draft LSPS and commended Council for the high-quality document that had been produced.

A range of matters were discussed at the meeting, as outlined in Table 1. As a result, it was requested that Council make a number of amendments to the Revised Draft LSPS before being formally submitted to the GSC for Assurance as the Final Draft Campbelltown LSPS. It is noted that formal correspondence from the GSC outlining the outcomes and requirements of the Final Health Check Meeting was only received on 6 February 2020.

The matters discussed at the meeting, and the requested amendments to the Final Draft LSPS, are summarised in Table 1 below.

It is noted that this matter was not raised or discussed at the Final Health Check but is included in the formal notes provided by the GSC. Previous discussions with the GSC (in September 2019) indicated that actions relevant to several topics in the LSPS should be included in each relevant section. Adjustments have been made where possible, given the limited timeframe to address this matter.

In addition to the above, minor updates have been made to the proposed Final Draft LSPS to reflect the decision to combine the proposed Cultural Plan and Creative Plan into one comprehensive document. Some minor formatting and design changes have also been made.

A copy of the Final Draft LSPS is provided at attachment 1.

3. Next steps and Timeframe

The remaining timeframe for finalising the LSPS is outlined in Table 2.

This timeframe is tight and cannot be altered. Council Officers are continuing to undertake the work required to achieve these deadlines.

At the Assurance Meeting (currently scheduled for 3 March 2020), the GSC will consider the Council endorsed Final Draft Campbelltown LSPS. It is anticipated that following the Assurance Meeting, Council will receive a letter of support from the GSC that may or may not include conditions or terms that Council needs to address before making the LSPS.

Once a letter of support has been received, Council (or the General Manager on behalf of Council, if delegation has been granted) can make the LSPS, subject to any conditions or terms of assurance. The LSPS also needs to be published on the DPIE e-planning portal. This needs to occur prior to 31 March 2020.

4. Conclusion

Council successfully prepared a Revised Draft Local Strategic Planning Statement and submitted it to the GSC for review. At the Final LSPS Health Check Meeting with the GSC and Government on 28 January 2020, Council was commended on the high quality of the document. Some amendments were requested. Wherever possible, these amendments have now been incorporated into the Final Draft Campbelltown Local Strategic Planning Statement (Final Draft Campbelltown LSPS), which is presented here to Council for consideration as part of this report.

It is required that Council endorse the Final Draft LSPS, and forward it to the GSC for the purposes of seeking Assurance so that the LSPS can be made.

There is limited time between the Assurance Meeting (3 March 2020) and the legislative deadline for the LSPS to be in place (31 March 2020). It is therefore recommended that Council provide the General Manager with delegation to undertake any minor amendments to the LSPS, and to make the LSPS, once Assurance has been granted and any conditions or terms that do not change the intent of the LSPS, have been addressed.

Council will receive a further information report once the Campbelltown LSPS has been made.
