2.03/18E COUNCIL RESOLUTION:

- 1. That an allocation of \$110,000 be made to Council's Gunnedah Memorial Pool Complex construction budget to be drawn from the Unrestricted Revenue Reserve;
- 2. That Council authorise a capital budget of \$35,000 for the Reservoir works to be drawn from the Gunnedah Water Fund; and
- 3. That an allocation of \$10,000 for professional services or legal advice be made to Council's Gunnedah Memorial Pool Complex Renewal Architectural budget to be drawn from the Unrestricted Revenue Reserve.
