

Executive summary

In September 2020, the Australian and NSW governments jointly committed \$20 million to investigate improvements to New Line Road from Old Northern Road, Dural to Castle Hill Road, West Pennant Hills, focusing on better traffic flow, safety and travel times for the growing population of Sydney's northwest.

Transport for NSW (Transport) is committed to identifying development options for the New Line Road corridor, that can be assessed against road safety standards, traffic efficiency, environmental impacts, property and community needs, constructability and delivery cost and budget.

As part of the project development process, Transport carried out early consultation with the local communities and road users. The public was encouraged to provide feedback relating to issues experienced while using the New Line Road corridor to provide Transport with a better understanding of how New Line Road is currently being used. The 'Have your say' consultation for New Line Road was held from 19 July to 18 August 2021.

This community consultation report provides an outline of the activities carried out during the 'Have your say' consultation for New Line Road from Old Northern Road, Dural to Castle Hill Road, Pennant Hills.

This report provides insight into the concerns raised and provides Transport with a better understanding of:

- How the local community and corridor users use New Line Road
- How active transport users use New Line Road
- Specific concerns raised by pedestrians and bikers
- Pinch point locations of congestion
- How the local community connects to places of significance.

Corridor information

New Line Road is part of Main Road 656 (MR656) which runs from Old Northern Road, Dural to Pennant Hills Road (Cumberland Highway), Pennant Hills via Boundary Road and New Line Road. This North-West to South corridor is the main alternative route for traffic coming from the northern suburbs (such as Dural and Galston) to access Pennant Hills Road.

The upgrade of New Line Road would improve safety, traffic flow, travel times and support the growing population of Sydney's Northwest, Dural and the Cherrybrook Priority Precinct.




Figure 1: Map of New Line Road and consultation corridor

Engagement approach

Engagement for this consultation was guided by the New Line Road Communication and Stakeholder Engagement Strategy (CSES). This section provides an outline of the engagement approach and consultation activities carried out in line with the CSES.

Engagement objectives

- 1. To gather community and stakeholder feedback relating to the existing New Line Road.
- 2. To develop a precinct-based approach to New Line Road Corridor, which demonstrates an understanding of the diversity of the community values of its people.
- 3. To ensure community and stakeholders know how to engage in the "have your say" consultation and provide feedback.
- To encourage surrounding local communities and road users to participate in the 'Have your say' consultation and to provide insights and their experiences relating to New Line Road.

Engagement methods and activities

Based on previous feedback received from the community about this road corridor, Transport anticipated consultation outcomes to be defined along certain sections of New Line Road. This led to the choice of the key engagement tool being the "Bang the Table' online platform due to the use of interactive maps.

Table 1 below provides an overview of the engagement methods carried out during the community consultation period from 19 July to 18 August 2021.

On 19 July 2021, a community update was produced and distributed by Transport to 2,400 properties within 200 metres of the New Line Road corridor from Castle Hill Road, Pennant Hills to Old Northern Road, Dural. A copy of this update can be found at Appendix A:.

Information regarding the community consultation, including links to the Transport website and "Have your say' portal, was also distributed via social media.

Community members were encouraged to have their say, with information on how the community could get involved and provide their feedback via phone, mail, post and email.

Feedback categories

The online "Have your say' interactive portal enabled participants to choose the following categories as subheadings to make comments. The sub-categories were:

- Congestion
- Safety
- Traffic Lights
- Pedestrian Crossings
- General

- Footpaths
- Cycling paths
- Accessibility
- Public Transport
- Environment

Key themes

During the consultation period, the following key themes were identified:

- Congestion
- · Pedestrian and bike provisions and safety
- · Safety of existing roundabouts

A detailed summary of location specific feedback obtained during the consultation is provided in Segment A to Segment F of this report.

Congestion

Congestion was one of the main concerns raised by stakeholders and the community. Feedback included:

- New Line Road users experienced congestion, particularly at key intersections such as at Shepherds Drive and County Drive, Hastings Road, Sebastian Road and Old Northern Road
- congestion at Pyes Creek, resulting from the two lanes to one lane merges
- suggestions made to improve traffic flow by providing continuous two lanes (each direction) along New Line Road.

Pedestrian and rider safety

Concerns were raised relating to the need for more active transport and pedestrian infrastructure along New Line Road. The feedback received was focused on community places of significance (local schools, shopping centres) and links to public transport.

Summary of feedback related to:

- the width of existing footpaths and surrounding safety of children walking/cycling along New Line Road, particularly near the local schools, shopping centres and Pyes Creek
- pedestrian connectivity across New Line Road was perceived by some as inadequate, specifically near roundabouts
- improvements to existing footpaths along New Line Road
- suggestions made for additional lighting to guide pedestrians along footpaths.

Safety concerns at existing roundabouts

The performance and safety of existing roundabouts was another key concern raised by the community and road users during the community consultation. Roundabouts along New Line Road mentioned include:

- Old Northern Road
- Dural Bunnings
- County Drive/ Shepherds Drive
- Boundary Road

Feedback outside consultation scope for the New Line Road corridor

During the community consultation, several comments were located outside of the identified scope of the New Line Road corridor. These comments mainly related to specific requests and a summary of these comments are included in this report.

Transport will forward these comments to the relevant local councils.

New Line Road corridor feedback

The feedback received from the consultation resulted in the clustering of comments along the road corridor. For the purpose of this report, these clusters have been categorised into six segments:






Figure 2: New Line Road corridor segments

Segment A – Intersection of New Line Road and Castle Hill Road

Segment A received a total of 26 comments relating to the intersection of New Line Road and Castle Hill Road, West Pennant Hills. Participants in the online consultation raised concerns regarding the current layout of the intersection, in particular the safety of pedestrians and motorists.

A summary of comments received for Segment A is provided at Table 4.




Figure 4: Overview of Segment A

Theme	Number of comments	Overview of comments
Congestion	9	 Concern regarding length of existing turning lane from Castle Hill Road into New Line Road. Request for dedicated turning lanes both into and out of New Line Road from Castle Hill Road to ease congestion. Suggestion for traffic light filter for traffic turning left onto Castle Hill Road from New Line Road.
Safety	8	• Concern over vehicles turning left onto Castle Hill Road from New Line Road not slowing down, leading to drivers on Castle Hill Road having to slow down.
		 Concern relating to pedestrians forced to walk around the back of vehicles queued in the left turning lane onto Castle Hill Road from New Line Road. Pedestrians often stopping on the walkway to view oncoming traffic. Concern regarding the safety of pedestrians, particularly children and pre-schoolers using this section of the road regularly. Suggestion for a pedestrian crossing further along New Line Road to increase safety of pedestrians.
Traffic Lights	3	 Comment relating to vehicles turning right from Castle Hill Road, often coming too close to cars waiting to turn right from New Line Road.
Pedestrian Crossings	1	 Concern regarding safety of children and families accessing schools and preschools using pedestrian crossing at the intersection.
General	4	 Feedback relating to poor mobile phone reception in this area, distracting drivers using GPS services. Feedback received for an extension of the right turn lane from Castle Hill Road into New Line Road, maintaining two separate lanes for straight through traffic on Castle Hill Road.
Footpaths	1	Suggestion for footpath being repaired along New Line Road between Castle Hill Road and Boundary Road.

Segment B - Boundary Road to Purchase Road

Segment B received a total of 219 comments with several comments relating to congestion at both Boundary Road and County Drive roundabouts. The community and road users expressed safety concerns using the road during peak hour traffic with congestion in these areas when using these intersections.

Feedback was received related to navigating the roundabout at Boundary Road in wet weather. Suggestions were made that the introduction of traffic lights at this location may improve safety for all users. Feedback in Segment B also included concerns about pedestrian and cyclist safety and the perceived need there is a lack of connectivity and provision of pedestrian access across New Line Road. A summary of comments received for Segment B is provided in Table 5.




Figure 6: Overview of Segment B

Theme Number of comments	Overview of comments
Congestion 30	 Concern regarding congestion at the intersection of County Drive/Shepherds Drive and New Line Road. Concern regarding traffic volumes at peak times on County Drive. Concern relating to congestion at the roundabout of New Line Road and Boundary Road during peak times. Concern that through traffic on New Line Road at the intersection with County Drive/Shepherds Drive is dominant which leads to congestion on County Drive and Shepherds Drive. Suggestion to add an underpass at the roundabout at the intersection of County Drive/Shepherds Drive and New Line Road, connecting Cherrybrook Village to Cherrybrook Metro station. Suggestion made for a right turn to be added from County Drive into Brokenwood Place, so residents do not have to use the roundabout at the intersection of County Drive/Shepherds Drive and New Line Road. Suggestion made for two right turn lanes from Boundary Road into Francis Greenway Drive. Suggestion made to retain the roundabout at the intersection of County Drive/Shepherds Drive and New Line Road. Suggestion for a new overpass at the intersection of County Drive/Shepherds Drive and New Line Road. Request for a bus lane to be added to Shepherds Drive. Request to implement a permanent clearway on Country Drive from Darlington Drive to the intersection of County Drive/Shepherds Drive and New Line Road. Request for County Drive to be made into a dual carriageway. Request for New Line Road to be widened to three lanes in each direction between the intersection of Boundary Road and New Line Road and the intersection of County Drive/Shepherds Drive and New Line Road. Request for dedicated left turn lanes to be added to the roundabout at the intersection of County Drive/Shepherds Drive and New Line Road.

Safety 34

- Concern there are no shoulder lanes along New Line Road.
- Concern regarding road user safety at the roundabout at the intersection of County Drive/Shepherds Drive and New Line Road, due to the amount of traffic.
- Concern that buses on New Line Road are unable to pull to the side of the road and let other traffic pass due to the placement of existing refuge islands.
- Concern regarding adverse gradient/slope on the roundabout at the intersection of New Line Road and Boundary Road travelling south on New Line Road to New Line Road, causing vehicles to slip in wet conditions.
- Concern about the lack of footpath for pedestrians on the western side of New Line Road between Purchase Road and the intersection of County Drive/Shepherds Drive and New Line Road.
- Concern over merge lanes leading to congestion and bottlenecks along New Line Road.
- Concern regarding a lack of lighting along the western side of New Line Road between Purchase Road and the intersection of County Drive/Shepherds Drive and New Line Road making it difficult to navigate the area at night.
- Concern regarding lane markings at the roundabout at the intersection of New Line Road and Boundary Road.
- Concern regarding safety of road users at the roundabout at the intersection of County Drive/Shepherds Drive and New Line Road due to congestion.
- Concern regarding safety of pedestrians at the intersection of County Drive/Shepherds Drive and New Line Road due to lack of pedestrian crossings and footpaths.
- Request for speed cameras to be installed along New Line Road.
- Request for the roundabout at County Drive/Shepherds Drive and New Line Road to be replaced with traffic lights.
- Request for a pedestrian and cyclist crossing to provide connectivity to Cherrybrook Metro station from the eastern side of New Line Road.
- Request for traffic lights to be installed at the roundabout at County Drive/Shepherds Drive and New Line Road to aid in managing traffic during peak hours.
- Request to reduce the slope of the roundabout to the kerb at the intersection of County Drive/Shepherds Drive and New Line Road.

Traffic Lights	60	 Several suggestions were received to install traffic lights at the roundabout of County Drive/Shepherds Drive and New Line Road to aid in managing traffic and pedestrians during peak hours. A large number of requests were received for traffic lights with a pedestrian crossing to be implemented on New Line Road near the bus stop between the intersection of Boundary Road and New Line Road and the intersection of County Drive/Shepherds Drive and New Line Road.
Pedestrian Crossings	58	 Request for more pedestrian crossings at the intersection of County Drive/Shepherds Drive and New Line Road. Request for more pedestrian crossings with traffic lights near bus stops between the intersection of Boundary Road and New Line Road and the intersection of County Drive/Shepherds Dive and New Line Road. Request to move the existing pedestrian crossing on Shepherds Drive closer to the roundabout at the intersection of County Drive/Shepherds Drive and New Line Road. Request for a pedestrian overpass or underpass to be installed at the intersection of County Drive/Shepherds Drive and New Line Road. Segment C-Purchase Road to Jenner Road

Segment C received a total of 237 comments. Congestion remained the top issue for this segment, followed by traffic delays through the section of New Line Road at Pyes Creek. It was also noted that the steep grade of the road in this area creates further delays as it is also a heavy vehicle route. Suggestions were received to widen New Line Road with two lanes of traffic in each direction.

This segment also included feedback related to safety concerns for both pedestrians and bikers. A summary of comments received for Segment C is provided at Table 6.




Figure 8: Overview of Segment C

Concern that widening New Line Road between Purchase Road and Jenner Road will lead to an increased volume of traffic. Request for New Line Road to be widened at Pyes Creek to further ease congestion.

Segment D - Jenner Road to Hastings Road

Segment D received a total of 172 comments. Similar to Segments B and C, concerns were raised regarding traffic and congestion, specifically at the intersections of New Line Road at both James Henty Drive/David Road and Hastings Road. Respondents noted heavy vehicle movements, steep road gradient travelling between Hastings Road and Jenner Road, and the use of merge lanes as contributors to congestion in this segment.

It was also noted there are limited safe active transportation options within this segment for both pedestrians and riders as an area of concern. A summary of comments received for Segment D is provided in Table 7.

Segment E – Hastings Road to Dural Golf Range

Segment E received a total of 125 comments. Congestion remained at the top of the key concerns, particularly during peak travel times and on weekends. Feedback was received about vehicles entering and exiting businesses along New Line Road in this segment as a contributing factor to the issue of congestion.

Other key concerns raised were related to both motorist and pedestrian safety, specifically a lack of provision to facilitate active transport. A summary of comments received for Segment E is provided at Table 8.




Figure 14: Overview of Segment F

The Australian and NSW Governments are investing \$20 million to investigate improvements on New Line Road, focused on better traffic flow, safety and travel times for the growing population of Sydney's north west.

Each day over 30,000 road users travel along New Line Road between Dural and West Pennant Hills. Due to the number of vehicles using this road, motorists experience heavy congestion, slow travel times and long delays while travelling along New Line Road. The Australian and NSW Governments are investigating options to upgrade this road to ease congestion, improve safety and cater for future growth in the area.




